Sir,

With due respect, I am producing herewith one accused person namely Jeherul Islam (43) S/o Abdul Jubbar of Jakhallibeelar Pathar, Malrajhar, Salbari PS Gobar Dhana Dist. Baksa, Assam under arrest along with seized cattle and seized vehicle :-

1. One Vehicle ( TATA Truck) having Registration No. NL-01-AF-1830 .
2. Twenty five (25) numbers of Cows and Thirteen (13) numbers of Calf in different color and different size which carrying in the Vehicle No. NL-01-AF-1830.


I, ASI Pradip Sarkar Of New Jalpaiguri PS under Siliguri Police Commissionerate do here by lodged a written complaint against the above noted accused person to the effect that on 09.04.24 at 13-55 hrs myself alongwith force were performing evening mobile van duty vide NJP PS GDE No. 520 dt. 09.04.24. At 20-40 hrs I received a secret source information that one vehicle are being loaded cows illegally coming through NH-27 road towards Jalpaiguri side from Phansidewa side without any valid documents/papers and if immediate action is taken, it can be apprehend . Accordingly I shared the information to duty officer and O.C. New Jalpaiguri PS which diarised vide New Jalpaiguri PS GDE No. 538 dt. 09.04.24. Thereafter as per your direction myself alongwith NVF-70 Nipen Roy , NVF-65 Prakash Roy with PSI Sonu Chik Baralk, C/1035 Santosh Rabi Das left for Fulbari to verify the veracity of information vide New Jalpaiguri PS GDE No. 539 dated 09.04.24 . At 21-15 hrs we reached at Fulbari More and just after few minutes on the basis of secret information we intercepted the one vehicle and apprehended the driver of the said vehicle having No. NL-01-AF-1830 . On checking the vehicle we found Twenty five (25) numbers of Cows and Thirteen (13) numbers of Calf in different color and different size were loaded on the vehicle. On being asked the apprehended driver disclosed his name and address mentioned above and admitted him as driver of the said vehicle and also stated he was carrying the Cattles in his vehicle from Dagarua Purnia , Bihar side towards Jalpaiguri for sale illegally. On asked, he failed to produce any license/ papers in support of carrying the said Cattles in that vehicle and also failed to produce any papers/documents in respect of the said Cattles. It is crystal clear and reason to believe that the above noted accused driver procured the said cattle by illegal means or by stolen means for dishonestly disposing of the same to earn huge money illegally. On further checking it was found that there was no arrangement made for food and water for the said Cattles as per Govt. rules. Besides this there was no sufficient space for the Cattles in that vehicle. The apprehended accused driver of the vehicle also failed to produce any papers/documents in support of the said vehicle. Accordingly I seized Twenty five (25) numbers of Cows and Thirteen (13) numbers of Calf in different color and different size and (ii) One Vehicle ( TATA Truck) having Registration No. NL-01-AF-1830 which was used to carry the Cattles as per proper seizure list duly sign by the witnesses. The seizure and arrest have been made in between 21-35 hrs to 22-20 hrs.

Under the above circumstances, I pray to you that a specific case may kindly be started against the above noted arrested driver namely Jeherul Islam (43) S/o Abdul Jubbar of Jakhallibeelar Pathar, Malrajhar , Salbari PS Gobar Dhana Dist. Baksa, Assam of the above noted seized vehicle having No. NL-01-AF-1830 to arrange for its investigation.


