Subject: First Information Report

I the undersigned would like to draw your kind attention towards the fact that I got married with one Sri Abhishek Giri, son of Late Pramod Giri, resident of Bahera Village, Near Nagar Robertsganj, District: Sonbhadra, Uttar Pradesh, Pin Code: 231216 on 21.04.2019 at Robertsganj, Varanasi, Uttar Pradesh, as per Hindu rites and customs in presence of my parents, other family members, friends as well as my present in-laws. That at the time of marriage my in-laws demanded a sum of Rs. 5,00,000/- (Rupees Five Lacs) only in cash, gold chain, gold rings, motorcycle, watch etc. and my father fulfilled all of their demands. That after my marriage when I reached my matrimonial house I could find that the behaviour of my in-laws especially my father-in-law, mother-in-law and younger brother-in-law was very much doubtful and questionable. Soon after my marriage I came to my parental house and stayed there for quite a few months and because of lockdown I could not go back to my matrimonial house. Subsequently due to lot of requests made to my husband by me, he took me back to my matrimonial house where I stayed for about 2 months. That on December, 2020 I got pregnant but due to ill treatment and tortures there was a miscarriage and at the same time my husband got a new job in Bilaspur, Chhattisgarh and my husband left me alone at my matrimonial house with my in-laws. That after few months living with my in-laws I requested my husband to take me to Bilaspur, Chhattisgarh where he was working at that time but after a lot of arguments he denied to take me with him. Finally, on

November, 2021 he took me with him to Bilashpur, Chhattisgarh and we started our married life. Thereafter in the month of February, 2022 I got pregnant and during that time my husband use to physically torture me every night in a drunken condition, due to which my health deteriorated drastically. That mostly I use to be alone at home during that time as my husband use to go on long work trips and after coming back he use to torture me both mentally and physically and this continued for about 3 months and even denied to take me to the Doctor. When my health deteriorated too much my husband called my father and ask my father to take me to my parental house so that they can take care of me. That on 02.11.2022 I gave birth to a girl child namely Amyra Giri and after hearing about the news that I gave birth to a girl child my in-laws especially my father-in-law was not happy and showered me with abusive languages and he went back to his house without even seeing my baby. Soon after that my husband and mother-in-law left. Thereafter my husband along with my in-laws stopped contacting me. It is pertinent to mention here that during the pregnancy and even after giving birth my husband and my in-laws never took any responsibility of me and my daughter and neither provide us with any monetary support, or with any food for my baby. It was always my parents and my brothers who took care of me and my daughter. That in the month of March, 2023 when my baby was 3 months old I tried communicating with my husband so that he can take us with him, but he denied and started fighting with me over phone. That after a lot of request on June, 2023 my husband visited me at my parental house at Prakash Nagar, Dr. Rajendra Prasad Road, ward No. 43 of the Siliguri Municipal Corporation, Post Office: Siliguri, Police Station: Bhaktinagar, District: Jalpaiguri, Pin Code: 734001 and started torturing me mentally and physically by stating that I could not gave birth to a male child and he does not want to stay with me. That in the month of October, 2023 I came to

know that my husband was having an illicit relationship in his work place and during Chhath puja my husband called me and forced me to sign divorce papers by using abusive languages. That on 2nd December, 2023 when I along with my child went to my matrimonial house i.e., Bahera Village, Uttar Pradesh I was showered with abusive languages and in some occasion I was thrashed and beaten mercilessly by my mother-in-law and father-in-law. The tale of such obnoxious behaviour continued till I was there at my matrimonial house and whenever I tried to talk to my husband about the same he always ignored me and my calls.

That in between all the tortures and assault I got a call from one Smt. Sona Goswami who introduced herself as my husband's wife and informed me that all my in-laws knew about their relationship and they got married and also told me to divorce my husband or else she will file a false complaint against me and my husband. That when I confronted my in-laws about the illicit relationship of my husband, I found out that they knew each and everything from the beginning and to the contrary my husband accepted the same when I confronted him when he came to the matrimonial house on 18.12.2023. After he accepted about his illicit relationship he promised me not to continue the same and on 23.12.2023 he left for Delhi for his new job where he is presently working. The illicit relationship continued even after my husband went to Delhi and the women he was with, use to call me almost every day just to convince me to divorce my husband.

Thereafter on 29.02.2024 my husband visited me to my matrimonial house and planned a short trip for us with his friend and wife and on 01.03.2024 we went for a drive just 15km away from my matrimonial house and inside the car they started drinking, seeing this I told them to sit somewhere and continue their party. Thereafter my husband booked a room at Sharda Hotel in Robertsganj and after getting drunk my husband's friend and wife left as because we didn't book any separate room for them. After

they left my husband in a drunken condition started abusing me both physically and mentally and when I tried stopping him he threw beer bottles at me and I was badly injured, seeing this my daughter started crying out of fear. After that I called for help and when the hotel staff came I called my brother and told him everything, seeing this, the hotel staffs called the Police. That out of fear I stepped out from the hotel room with my daughter so that I can save myself and my daughter but my husband came running at me and started pulling me by my hair and dragged me inside the hotel room and snatched my mobile phone being model One Plus, Knot C3 and Purse and strangled me in the hotel. That even before the Police personnel arrived I somehow manage to escape from hotel room in a single piece of cloth without my documents, mobile, purse, other belongings at around 7:30 p.m. to save me and my daughter. Thereafter I went to the nearby bus stand without my belongings and after reaching the bus stand I tried contacting my parents and brothers through a stranger. After communicating with them they send me some money for bus ticket and I took a bus from Robertsganj to Varanasi. That after reaching Varanasi I stayed at Varanasi Station whole night with my daughter and was continuously contacting my brothers through strangers and in the morning I bought a phone from a nearby shop and my brother paid the bill amount online. Thereafter my brother send me flight tickets from Varanasi to Bagdogra and some money.

On 02.03.2024 I came to Siliguri and after reaching my health deteriorated. On 03.03.2024 I got admitted in Star Hospital, near Fulbari, Siliguri and after final diagnosis I was discharged on 05.03.2024.

It is pertinent to mention here that at present I am residing with my ailing parents, my father aged about 70 years, and my mother aged about 65 years and my minor daughter alone at Residing at Prakash Nagar, Dr. Rajendra Prasad Road, Ward No. 43 of the SMC, Post Office: Siliguri, Police

Due to such incident which took place on 02.03.2024 I got traumatized and thinking about the security of my minor child and my ailing parents I could not take appropriate steps at the earliest. Under these circumstances I would like you take appropriate steps in this matter and book the above mentioned persons under the suitable provisions of law.
