Sir,

I, Sri Tapas Bishui, S/O-Late Birendra Nath Bishui, Assistant Engineer & Station Manager, Hakimpura CCC, WBSEDCL under Siliguri P.S., empowered by the Electricity Act 2003 do hereby lodge this complaint for the theft of property of WBSEDCL by unknown miscreants from the structure of distribution transformer on 08.04.2024 at around 06.30 a.m. Upon inspection, it is found that, 03 nos of M.S. Angle 65x65x6 mm (Kiosk angle, Material Code-0101011311), each length of 2.5 meter have been stolen from the structure of distribution transformer at below mentioned location:-

- 1) DTR Code - 9M02M, Location - Baghajatin Park, Near Sikkim Manipal University, Baghajatin Road, Ward No.-17, Siliguri.
- 2) DTR Code - 9M01S, Location – Near Sphulinga Gas, Opp. White Apartment, Baghajatin Road by lane, College Para, Ward No.-17, Siliguri.
- 3) DTR Code - 9M02O, Location - Ashutosh Mukherjee Road, Near Sun View Apartment, College Para, Ward No.-17, Siliguri.

In view of the safety this type of activity is very dangerous for the person doing this misdemeanor and also for the local people too. This wicked act caused financial loss of the WBSEDCL of Rs. 10,000.00/- (Rupees Ten thousand only).

So, this is to request to your good office to register a F.I.R. u/s 136(1)(a) and u/s 140 Of Electricity Act 2003 so that the matter can be thoroughly investigated for taking necessary actions at the earliest.
