4. That it is pertinent to mention here that I do not own any two-wheeler bearing this no., and however I have a car with the same number and this is doubt and fear that someone is illegally using my number plate which is very unfortunate.

It is pertinent to mention here that I do not own any scooty.

Under the above circumstances I would request you to kindly look into the matter treat the instant prayer as F.I.R and curb such illegal act and activities under relevant sections of the law of the land and do the needful as you may deem fit and proper.
