I, Smt. Malbhogiya Ram W/O Late Sitaram Ram, aged about 80 years, resident of Balaram Nagar, Upper Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling, beg to inform you that on 03.04.2024 at around 6:00 p.m. in the evening one 1. Miss. Pramila Ray and 2. Miss. Mala Ray both are daughters of Late Shankar Ray of Balaram Nagar, Upper Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling without any rhyme and reason caught me in my hair and pulled me as a result of which I am having severe pain in my head. That they kept abusing me with filthy language and threatened me with dire consequences. That their brother 3. Sri Sunil Ray intervened and he too threatened me that he will kill me and my son by hiring persons from outside. That they tried to hit me with fists and blows without any provocation but somehow I managed to save myself from them when my relatives came to save me.

That I am a senior citizen but everytime when the complained persons see me they pass filthy remarks. These persons have made my life miserable and I fear to step out of my house due to this behaviour of theirs. That the delay in reporting the issue is due to my ill health.

I, therefore, request your goodself to enter my report in the GDE maintained by you and be further pleased to enquire into the matter and take necessary action against the abovenamed complained person for the ends of justice and for that act of kindness I shall be ever grateful to you.
