In producing herewith following three accused namely i) Sambhu Roy (23yrs) S/O Bipul Roy, of South Rath Khola near kalimandhir PO+PS Naxalbari, Dist Darjeeling (not verified), ii) Tantu Raha @ Kankan (28yrs) S/O Kanu Raha, of Rath Khola more near Sivaji Shankar Club PO+PS Naxalbari, Dist Darjeeling (not verified), iii) Mantu Sarkar (33yrs) S/O Goutam Sarkar of Tungudegi colony para PO tungudegi PS Karamdeghe Dist Uttar Dinajpur, A/P Sevoke road near payal more PS Bhaktinagar Dist Jalpaiguri (not verified), iv) Bishnu Barman (19yrs) S/O Subash Barman, of Vivekananda nagar ward no 42 PO Salugara PS Bhaktinagar Distr Jalpaiguri (not verified), with following seized articles viz:

- 1) One iron made sharp cutting knife and one iron rod (sabol) measuring 18 inches recovered from the conscious possession of Sambhu Roy
- 2) One iron made 'Knife' and rope recovered from the Conscious possession of Tantu Raha @ Kankan
- 3) One iron made weapon called as 'Bhojali' 14 inches recovered from the conscious possession of Mantu Sarkar.
- 4) One iron rod approx 24 inches recovered from the conscious possession of Bishnu Barman

I, SI Youel lepcha S/O Jai Tshering Lepcha of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted i) Sambhu Roy (23yrs) S/O Bipul Roy, of South Rath Khola near kalimandhir PO+PS Naxalbari, Dist Darjeeling (not verified), ii) Tantu Raha @ Kankan (28yrs) S/O Kanu Raha, of Rath Khola more near Sivaji Shankar Club PO+PS Naxalbari, Dist Darjeeling (not verified), iii) Mantu Sarkar (33yrs) S/O Goutam Sarkar of Tungudegi colony para PO tungudegi PS Karamdeghe Dist Uttar Dinajpur, A/P Sevoke road near payal more PS Bhaktinagar Dist Jalpaiguri (not verified), iv) Bishnu Barman (19yrs) S/O Subash Barman, of Vivekananda nagar ward no 42 PO Salugara PS Bhaktinagar Distr Jalpaiguri (not verified), and 7/8 others to the effect that on 11/04/2024 at 00:15 hrs received a specific source information that 11/13 miscreants have assembled at Tara Chand Mat near Shiv mangal high School under Bhakti Nagar PS, Dist.- Jalpaiguri with deadly weapons and making preparation for committing dacoity at Iskon mandhir area under Bhakti nagar PS area. Accordingly, I informed the matter to the I/C, Bhakti Nagar PS and diarised the fact in General diary vide Bhakti Nagar PS GDE No 508/24 dated 11.04..2024 and as per order I along with ASI Dipak Karmakar, ASI Chandra Prakash Adhkari, C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for Tara Chand Math near Shiv mangal high School under Bhakti Nagar PS, Dist.- Jalpaiguri to work out the information in hand. At about 00.35 hrs we arrived at Tara Chand Math near Shiv mangal high School under Bhakti Nagar PS, Dist.- Jalpaiguri as indicated by the source we noticed that 11/12 persons assembled at Tara Chand Math near Shiv mangal high School under Bhakti Nagar PS and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after a hot chase managed to apprehended above noted 04 (four)

of them with deadly weapons in their possession but 7/8 persons managed to fled away from the spot taking the advantage of darkness and open place.

On interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that the following persons namely Rajiv, Bijay Mahato, Gopal Pinku, and others were present there and making preparation for committing dacoity at Iskon mandhir area under Bhakti nagar PS area. On search the above noted weapon of offence recovered from their exclusive and conscious possession. One iron made sharp cutting knife and one iron rod (sabot) measuring 18 inches recovered from the conscious possession of Sambhu Roy, One iron made 'Knife' and rope recovered from the Conscious possession of Kankan Raha @ Tantu, One iron made weapon called as 'Bhojali' 14 inches recovered from the conscious possession of Mantu Sarkar, One iron rod approx 24 inches recovered from the conscious possession of Bishnu Barman.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 11/04/2024 in between 01.05hrs and 01.55 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 04 (four) arrested accused persons namely i) Sambhu Roy (23yrs) S/O Bipul Roy, of South Rath Khola near kalimandhir PO+PS Naxalbari, Dist Darjeeling (not verified), ii) Tantu Raha @ Kankan (28yrs) S/O Kanu Raha, of Rath Khola more near Sivaji Shankar Club PO+PS Naxalbari, Dist Darjeeling (not verified), iii) Mantu Sarkar (33yrs) S/O Goutam Sarkar of Tungudegi colony para PO tungudegi PS Karamdeghi Dist Uttar Dinajpur, A/P Sevoke road near payal more PS Bhaktinagar Dist Jalpaiguri (not verified), iv) Bishnu Barman (19yrs) S/O Subash Barman, of Vivekananda nagar ward no 42 PO Salugara PS Bhaktinagar Distr Jalpaiguri (not verified), and others kindly arrange for its investigation.
