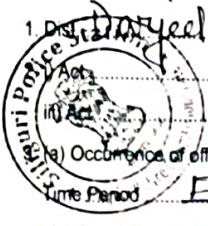

I Smt. Sonali Paul, Wife of Late Bimal Paul, Daughter of Late Kalachand Paul, Resident of Rabindra nagar, Dudh More, near Purbachal Club, Post Office – Rabindra nagar, Police Station- Siliguri, Darjeeling-734006, would like to state that I got married to my husband Bimal Paul (now deceased) sometime in the year, 1978. Out of the said wedlock two children were born one being my elder son Sri. Biltu Paul and one daughter Smt. Piu Pandit (Paul). Thereafter, my husband expired on 1985. Being a single mother I had to endure a lot hardship and struggle all throughout my life to raise with a hope and expectation that they will look after me when I am old and ailing. My daughter Smt. Piu Pandit (Paul) got married in the year, 2004. Later, my son also got married to Smt. Sushmita Kundu Paul, in the year 12.03.2017, the said marriage was a love marriage and after the marriage upon the request of my son I had given my entire jewellery to my daughter in law. It is pertinent mention here that after the marriage of my son his temperament changed and his behavior towards me became more and more aggressive with each passing day. When I enquired him about such sudden change in behavior he out rightly alleged that I force my daughter in law to work like a maid servant in the household daily whereas the truth is entirely different. My daughter in law has never worked a single day since the marriage all the household works are being done by me rather she used to abuse me and provoke my son against me every day after he used to come from work. My son used to come to the house late at night every day in an utter state of intoxicated and after meeting with my daughter in law, and upon her provocation used to turn violent and used hands on me and beat me with fists and blows and further abuse me with filthy and abusive languages. This instance of physical torture continued for years and I have been silently enduring mental and physical torture at the hands of my son and daughter in law since the inception of their marriage. My daughter in law has been in active participation with my son in inflicting all sorts of mental and physical trauma and numerous occasions and I have silently enduring such torture since long. My son would beat me with dangerous weapons which may severely injure me At one instance he hurt me so grievously I had contacted my daughter who arrived at the scene and took me to hospital for immediate treatment. However, I did not file any written complaint against my son hoping that one day he will realize his mistake and one day mend his ways but in vain. He further threatened my daughter i.e., his sister and her husband i.e., my son in law that he will kill them if they tried to stop him or report him and if they enter the house he will burn the house. Recently, the tortures of my son and daughter in law had increased and on 09.04.2024 at 5 p.m. suddenly my daughter in law and my son attacked me and hit me in my chest and physically flung me across our house and thereafter pulled me and at particular instance I got injured in my hands, neck and legs thereafter assaulted me with fists and blows. My son suddenly grabbed me by my neck and to tried to choke me with the only intention to kill me. I started to save myself from my son and started screaming and yelling. I somehow tried to save myself and escaped from my son and daughter in law. The mere intention of my son was to kill me.


I somehow managed to escape from the house and save my life. I also fear that my son had the intention to kill my daughter and her husband also. Thereafter since I was not having enough money to visit a doctor (private practitioner) I had to visit the Siliguri District Hospital for my emergency first aid and treatment.

I fear that my son now will cross any limits to cause grievous hurt/ kill me and my daughter.

I therefore request you to investigate the matter and book the culprits in accordance with the appropriate provisions of law.
