Respected Sir,

With due respect I, **SRI PRANTOSH KUMAR SAHA**, Son of Late Shyamal Saha, Resident of Chowrahat Bazar, Ward No. 13, P.O. & P.S. Dinahata, Dist. Cooch Behar, would like to lodge this Written Complaint to the effect that I am an old aged person (70 Years) and being a Senior Citizen, I have been suffering with severe old aged ailments since long. Sir, I have two sons namely Parijat Kumar Saha and Indrajit Kumar Saha and both of them are married and I am residing with my elder son at Dinahata and he is maintaining and taking proper care upon me as per his best efforts.

Sir, it is pertinent to mention here that I am the absolute owner in possession of all that piece or parcel of a plot of land measuring 2 Katpas or 0.033 Acre, appertaining to and forming part of Plot No. 12154, recorded in Khatian No. 2719 corresponding to 2798/3 held under the State of West Bengal yearly rented of Rs. 9.00 Paise, situated within Mouza - Siliguri, J.L. No. 110(88), Touzi No. 3(Ja), Pargana - Baikunthapur, Holding No. 32/92/304/231/1 of Ward No. 29 of Siliguri Municipal Corporation at Deshbandhu Para, M.M. Dutta Road Bye Lane, within the Jurisdiction of Police Station and A.D.S.R. - Siliguri, Dist. Darjeeling, and I have acquired the plot of land by virtue of a Deed of Conveyance, executed by Sri Amar Chandra Das on 29/07/2003 and the same was duly registered in the Office of the A.D.S.R. - Siliguri being Document No. I - 143 for the year 2003 and after acquiring the aforesaid land, I have constructed a two storied house structure in and over my aforesaid landed property for residential purpose from my own fund and since after the marriage of my younger son with said Rumki Saha, they have requested me to allow them to reside in my said property for their smooth convenience and considering their said approach and request, I being the father, have allowed them to reside in the said property freely, with a hope that they will look after me and also maintain me during the last days of my life.

Sir, practically there was no problem in our family and we used to live and maintain our daily life happily but it is very painful to mention here that after the marriage of my younger son with said Smt. Rumki Saha, the atmosphere in our family become obnoxious. They did not even bother to give any respect to me and also used slang and filthy languages towards me and inspite of that, I being their father, used to give proper love and respect to them with a hope that in future they will definitely realize their own mistake and thereby, rectify themselves but all my hopes have gone in vain.

In the mean time, my younger son and his wife in conspiracy with each other, have started to create tremendous pressure upon me to transfer my aforesaid property in their favour though, I have allowed them to reside in my aforesaid property for their smooth and peaceful conjugal life and when I denied to transfer the aforesaid property in their favour and also made protest against their such type of illegal demand, they became furious and started to abuse me with filthy and slang languages without considering my old age and relation amongst us and also threatened me by saying that if I will not transfer the aforesaid property in their favour, they will not hesitate to ruin my life and property and thereby, grab my own property forcefully and most illegally.

Sir, in the First Week of March, 2024, I have visited in my aforesaid house situated at Deshbandhu Para, M.M. Dutta Road Bye Lane, with a view to stay there for few days as during that time, the date was fixed for operation of my eye but it was very scary and unfortunate for me that on the very day at night at about 11.00 P.M., my younger son in conspiracy with his wife, have assaulted me physically and also ousted me from my own house forcefully and they have also threatened me by saying that if I again dare to enter into the said house, they will not hesitate to kill me by pressing my throat and thereafter, finding no other alternative, I left my own house under compulsion and took shelter in the in laws house of my elder son at East Vivekananda Pally, Siliguri and due to their sudden attack and misbehavior, I had fallen seriously ill and passing my days with extreme fear and mental trauma.

I, therefore, being a senior citizen, fervently requesting you to look into the matter properly and please take necessary steps against my younger son namely Sri Indrajit Kumar Saha and his wife Smt. Rumki Saha as per the provision of law so that we can live our remaining life peacefully in our own property and obliged thereby.
