I Birendra Kumar Yadav, the above noted complainant beg to inform you that on dt 10.04.24 at about 07:30 am, when I was going to make payment of cattle feed, and reached in front of house of my neighbour namely, Ram Pravesh Roy at Ganga Nagar (Ice Factory Road), Ward No.5 SMC, at that time, my above noted alleged neighbours namely (1) Ram Pravesh Roy S/o Sri Dwarika Roy (2) Rajesh Yadav @ Roy & (3) Pawan Yadav @ Roy both sons of Sri Ram Pravesh Roy, & (4) Smt. Rina Yadav w/o Sri Rajesh Yadav @ Roy, restrained me and started abusing me in filthy languages and when I protested, the said persons namely, (1) Rajesh Yadav @ Roy & (2) Pawan Yadav @ Roy brought Botam (wooden logs) from their house and badly hit on my head & body, and I received severe head injury and on the other parts of my body, and all above noted alleged persons started beating me brutally with hands & feet and stolen away Rs 5800/- (Rupees Fifty Eight) thousands only from my pocket.

Sir, I immediately shifted to Siliguri Distt. Hospital & treated myself there.

So, please take necessary action against above noted alleged persons
