Sir,

With due respect, I Smt. Rina Yadav W/o Sri Rajesh Yadav, resident of Ice Factory Road, Ganga Nagar, Ward No - 5, P.O - Siliguri Bazar, P.S - Siliguri, District - Darjeeling, would like to inform you that today i.e. 10 - 4 - 2024 at about 6.30 am I alongwith my husband Sri Rajesh Yadav were going to our cow shed to feed our cow and to fetch milk, and when we are about to reach to our cow shed, one Birendra Yadav S/o Sri Munsri Yadav and Pradeep Roy S/o Not Known both are resident of Ice Factory Road, Ganga Nagar, Ward No - 5, P.O - Siliguri Bazar, P.S - Siliguri, District - Darjeeling, have started making vulgar comments upon me and when my husband raised his objection the said Birendra Yadav, and Pradeep Roy caught hold me and have started oughr raging my modesty by touching my private parts and when they tried to take me in their cowshed forcibly, and when my husband raised his serious objection about such act of them by raising his voice, one Sharma Yadav S/o Munsri Yadav and Manish Yadav S/o Late Parma Yadav both are resident of Ice Factory Road, Ganga Nagar, Ward No - 5, P.O - Siliguri Bazar, P.S - Siliguri, District - Darjeeling, came forward with bamboo lathi and upon their inducement, the said Birendra Yadav, hit my husband upon the head of my husband by a bamboo lathi after snatching the same from the hand of Manish Yadav resulting which my husband fell down in senseless condition and upon my hue and cry when the local persons have started gathering the above named persons have started fleeing from the place and in the mean time during fleeing, the said Birendra Yadav fell down and sustained head injury.

Due to the said assault by Birndera Yadav, my husband became senseless and any how I with the help of my relatives and local residents, have shifted him to North Bengal Medical Collage and Hospital and he was admitted by the doctors considering his injuries. Presently my husband is fighting for his life and death in hospital and as I was in shocking state of mind after such incident and busy in the treatment of my husband, I could not lodge my FIR within time.

So requesting you to investigate the matter and take necessary legal action against the above named persons for the interest of justice.
