Sir,

I, **Sri Koushik Sharma, Son of Rajen Sharma**, resident of Battalion More, Fulbari, Dabgram, District Jalpaiguri, would like to formally lodge this complaint against one **Smt. Rinta Saha Das (Mob. 9749519732)**, resident of Saktigarh, SMC Ward No. 32, Siliguri and one **Sri Dhruba Shankar Pal (Mob. 9339770134)**, resident of Near Ashok Nagar Sporting Club, Ashok Nagar, SMC Ward No. 31.

Sir, I along with, **Sri Tanmoy Chakraborty**, Son of Tapan Chakraborty, resident of Noukaghat Main Road, SMC Ward No. 31, District Jalpaiguri and **Sri Debashis Bhattacharya**, Son of Tara Shankar Bhattacharya, resident of Chandraloke Complex, 58 Bhatshala Road, Post Office Shreepally Police Station Burdwan Sadar, Burdwan, District Purba Burdwan, PIN- 713104 are an Employee for Kepler Healthcare Pvt. Ltd. In our company, one Dhruba Shankar Paul (9339770134) was also an employee previously, but due to some reasons, the company had terminated him from his job. Sir, we were absolutely unaware of such termination of Dhruba Shankar Paul, and only came to know about that many months later.

Sir, thereafter, the said Dhruba Shankar Paul, had tried to contact us, and also had previously threatened us regarding our jobs. Thereafter, for the purpose of work, me along with some of my other colleagues including Sri Tanmoy Chakraborty and Sri Debashis Bhattacharya were visiting a Doctor's Chamber in Hill Cart Road, Near Biswadeep Traffic Point, Pradhan Nagar, Siliguri on 09/04/2024. Sir, around 7:00 PM in the evening on 09/04/2024, while I along with others above named were waiting outside the said Doctor's Chamber as stated above, Dhruba Shankar Pal along with Rinta Saha Das and a minor child entered the said Doctor's Chamber waiting area. Suddenly, the said Dhruba Shankar Pal started abusing me verbally saying that it is because of me and other office colleagues of his because of whom he has lost his job and pointed us towards Rinta Saha Das, who suddenly started shouting at us saying that since Dhruba Shankar Pal had lost his job, they will also not let us work in the same company and started abusing me any my other colleagues in filthy language and suddenly grabbed my collar and dragged me outside towards the stairs. When others as above named, tried to stop her, and asked her about the matter, she charged at them and hit them with fists and blows and also started threatening me that she will ruin my reputation amongst public and in my workplace and also never let me work again by posting false statements against me on various social media platforms and will send her musclemen and will kill me and harm my family.

Sir, in the meantime, the said Dhruva Shankar Pal also charged at me and my colleagues above named and hit me and my colleagues with his helmet in my head, and hit Sri Debashis Bhattacharya in his private areas (groin region) with Kicks and Helmet, and the shoulder and also with fists and blows and kicks. He too started shouting at us in filthy and abusive language stating that since he had lost his job, he will also no let me and my colleagues work in the company and will lodge false complaint with the said Rinta Saha Das.

Sir, thereafter, both Dhruva Shankar Pal and Rinta Saha Das pushed Sri Tanmoy Chakraborty from the stairs and he suffered an injury in his ankle. We hurriedly came outside in the Hill Cart Road, and there too both of them slapped Sri Tanmoy Chakraborty and again started pushing us others above named and using filthy language and threatened us that she will lodge false police complaint against me and my colleagues above named as all the police officers are known to her and she can buy them.

Sir, I am sales promotional employee and work daily in public places and my and my colleagues above named reputation is one key criteria of our job. I and my colleagues above named am living in a constant sense of fear and mental agony and the same has been affecting my job as it has reached my workplace.

In the above circumstances, I therefore, humbly pray before you to look into the matter immediately for the ends of justice and resist the above persons to do such illegal acts and/or to take the law on their own hands.

Hope your kind co-operation and need full legal action please in the interest of Justice.
