Sir,
With due respect, I am producing herewith the 06 (six) arrested accused persons namely (i) Md. Munna (30), S/o- Lt. Md. Habib Sk of Biswas Colony, PS- Matgara, Dist- Darjeeling, (ii) Dipankar Adhikary (30), S/o- Naren Adhikary of Tumbajote, Near Gour Iccha Kali Bari, PS- Matigara, Dist- Darjeeling, (iii) Roshan Ali (24), S/o- Kuddus Md. of Biswas Colony, Sutki Godown, PS- Matigara, Dist- Darjeeling, (iv) Gopal Karmakar (22), S/o- Lt. Bimal Karmakar of Pati Colony, Road No.2, PS- Pradhan Nagar, Dist- Darjeeling, (v) Sahadeb Barman (31), S/o- Jiten Barman of Rabindra Nagar, Tumbajote, PS- Matigara, Dist- Darjeeling and (vi) Md. Afjal (22), S/o- Md. Alam of Biswas Colony, Rail Gate, PS- Matigara, Dist- Darjeeling and the following articles under seizure :-

1. One iron made Ram Dau from the possession of accused named Md. Afjal
2. One iron rod from the possession of accused named Gopal Karmakar
3. One iron rod and one screw driver from the possession of accused named Md. Munna.
4. One bhojali and one torch light from the possession of accused named Dipankar Adhikary.
5. One wrench and one small iron rod from the possession of accused named Roshan Ali.
6. One knife and one torch light from the possession of accused named Sahadeb Barman.

I, SI Shib Sankar Das of Matigara PS, Siliguri Police Commissionerate beg to state that on 13.04.2024 at 00.10 hrs. received a secret source information that a gang of miscreants were assembled at Matigara Rly. Station, PS- Matigara, Dist- Darjeeling with deadly weapons and making preparation for committing dacoity at Matigara Bazar area. Accordingly, I informed the fact to I/C, Matigara PS and diarized the matter vide Matigara PS GDE No- 698, Dated- 13.04.2024. As per your kind order myself along with ASI Dharendra Nath Mandal, ASI Pema Dorjee Sherpa, C/523 Sanjit Kundu, C/219 Sanatan Chitrakar, C/868 Sujal Roy all are of Matigara PS, Siliguri Police Commissionerate left for Matigara Rly. Station, PS- Matigara, Dist- Darjeeling to work out the information in hand vide Matigara PS GDE No. 699, Dated- 13.04.2024. At about 00.25 hrs on 13.02.2024 we arrived at Matigara Rly. Station under Matigara PS. After arrival of the spot and as identified by the source we found that 10/12 persons were assembled in a abandon room of Matigara Railway Station and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended 06 (six) persons of them. On interrogation the apprehended accused persons, they disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there to commit dacoity in Matigara Bazar area. They also stated that others 04/06 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 06 (six) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 00.45 hrs to 01.48 hrs on 13.04.2024.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely i) Md. Munna (30), S/o- Lt. Md. Habib Sk of Biswas Colony, PS- Matgara, Dist- Darjeeling, (ii) Dipankar Adhikary (30), S/o- Naren Adhikary of Tumbajote, Near Gour Iccha Kali Bari, PS- Matigara, Dist- Darjeeling, (iii) Roshan Ali (24), S/o- Kuddus Md. of Biswas Colony, Sutki Godown, PS- Matigara, Dist- Darjeeling, (iv) Gopal Karmakar (22), S/o- Lt. Bimal Karmakar of Pati Colony, Road No.2, PS- Pradhan Nagar, Dist- Darjeeling, (v) Sahadeb Barman (31), S/o- Jiten Barman of Rabindra Nagar, Tumbajote, PS- Matigara, Dist- Darjeeling and (vi) Md. Afjal (22), S/o- Md. Alam of Biswas Colony, Rail Gate, PS- Matigara, Dist- Darjeeling and others and arrange for its investigation.
