Dear Sir,

This is to inform you that myself Rehana  
Khatoun, w/o Md. Alam residing in Ashrafnagar  
since birth, I have three children, my husband  
is a mason by profession, whose permanent  
address is Ramgung, Po + PS. Chopra.

Me and my 11 yr baby girl, other 9 yrs old  
suffered an unfortunate incident in absence  
of my husband. Everything started on 9th April  
evening when my children was beaten by one  
Md. Masto after mere quarrel with his son  
Md. Jamshed (14-15 yrs).

On 10th April again Md. Masto at around 11 am  
furiously hit both my daughters with fists  
and blows, she suffered (my younger daughter)  
a severe hit in her chest (left upper Rib).

When I came to rescue my helpless daughters  
that Md. Masto took out an sharp weapon  
(Dao) and grabbed my face and assaulted  
me. Medical report attached herewith. My  
neighbours and local people came running  
and rescued me. I called up my husband  
for SOS and ran to SD Hospital, Siliguri  
with my daughters for treatment.

Actually, Sir we are in trauma, fear  
and helplessness, both my daughters are in  
panic attack, moreover that Md. Masto  
the anti-social holligan is staying

just beside our rented room in a same premise. Not only us but after that incident of 10th April 2024 other co-tenants are scared and upset.

Sir, detail investigation for the above is highly solicited, because there are eye witness, I'm in extreme shock and panic to watch my elder daughter Ruksana khatoon being picked up by the monster and he threw her on drain. He is assuming himself as (Rowdy Pada)

Sir, an early action for the above in duty to protect our lives and souls is highly anticipated.
