in producing herewith, two (02) accused persons namely [1] Ashim Sarkar (M/34 years), S/O- Santosh Kumar Sarkar of Jitpur-1, P.O + P.S Dinhata, Dist Coochbehar, Presently residing at Idol Complex, Flat No. G-1, Gate no 01, Opposite Coochbehar Club, P.S Kotwali, Dist Coochbehar and [2] Bhola Roy (M/55 years) S/O- Lt. Ganapati Roy of 1 No Kalighat Road near Station Para, Mal Gudam, PS- Kotwali, Dist- Coochbehar along with following seized articles under proper seizure list.

- i] One iron made improvised small firearms (Revolver) with butt measuring 30 cm (approx) in length from its barrel to butt having one striking pin, striking hammer and trigger in working condition,
- ii] One round live ammunition,
- iii] One White coloured Tata Nexon vehicle bearing Regd. No. WB 74 BR 8509.

I, SI Chetan Dangal of Ambari O.P under Bhorer ALO P.S, Siliguri Police Commissionerate, do hereby lodge this written complaint against the above noted accused persons namely [1] Ashim Sarkar (M/34 years), S/O- Santosh Kumar Sarkar of Jitpur-1, P.O + P.S Dinhata, Dist Coochbehar, Presently residing at Idol Complex, Flat No. G-1, Gate no 01, Opposite Coochbehar Club, P.S Kotwali, Dist Coochbehar and [2] Bhola Roy (M/55 years), S/O- Lt. Ganapati Roy of 1 No Kalighat Road near Station Para, Mal Gudam, PS- Kotwali, Dist- Coochbehar to the effect that on 12.04.2024 at 15:25 hrs received secret

information from Jalpaiguri side from Siliguri side and the persons boarded on the vehicle were possessing illegal firearms. Accordingly, I diarized the matter in Ambari Falakata OP GDE No. 441 Dt. 12.04.2024 and shared the information to O/C Ambari Falakata OP under Bhorer ALO PS- SFC in written and subsequently, being directed, I along with C/975 Swarup Basak and NVF/131 Bidhan Ch. Roy left for Sitaguri with investigation kit box on Govt. vehicle for verifying the veracity of the information. This refers to Ambari Falakata GDE No. 442 Dt. 12.04.2024 and MCC No. 597/2024 Dt. 12.04.2024.

On way to Sitaguri, I contacted two persons namely 1) Md. Moksed (20), S/O- Md. Jaddil and 2) Gouranga Das (34), S/O- Bikram Das both are of Sitafuri, PS- Bhorer ALO, Dist- Jalpaiguri and make them aware of the information in hand and requested them to act as witness. If any search and seizure would be made necessary upon which they agreed. Subsequently, I along with force and the independent witnesses further proceeded for Sitaguri.

At 16.05 hrs we reached at Sitaguri and started waiting for the vehicle bearing Regd. No. WB 74 BR 8509 at Sitaguri on Asian Highway-2 near Royal Petrol Pump. At 16.15 hrs we detained the vehicle bearing Regd. No. WB 74 BR 8509 on Asian Highway-2 at Sitaguri near Royal Petrol Pump and it was found that above noted accused Bhola Roy was driving the vehicle and the accused Ashim Sarkar was sitting on the front seat at the left side of the

On interrogation, they disclosed their identities as noted above. Subsequently, I searched their possession as well as the vehicle bearing Regd. No. WB 74 BR 8509 in presence of the independent witnesses and recovered one iron made improvised small firearms (Revolver) with butt being loaded with one round ammunition, which was kept concealed at the left side waist of accused Ashim Sarkar underneath the T-shirt. Subsequently, being asked, he failed to produce any documents in support of his possession
