Sabir of Koyla Depo , Vivekananda Road, Ward No.- 07, P.S- Siliguri, Dist.- Darjeeling (iv) Ronak Singh (19) S/O Binod Singh of Rajib Nagar, P.S- Pradhan Nagar, Dist.- Darjeeling and (v) Raghbir Das (19) S/O Kedar Das of Thhakar More, South Ambedkar Colony, P.S- Matigara, Dist.- Darjeeling and the following articles under seizure :-

I, ASI Uttam Kumar Dhar of Khalpara TOP Under Siliguri Police Station, Siliguri Police Commissionerate beg to state that on 13.04.2024 at 00.15 hrs I received a secret source information that a gang of miscreants come to Mahananda River Bed near Jyotinagar W/No 04 under Khalpara TOP, Siliguri PS with deadly weapons and assembled there and making preparation for committing dacoity at Jyotinagar area under Khalpara TOP, PS- Siliguri , Dist.- Darjeeling. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -I, SPC and diarized the fact in General diary vide Khalpara TOP GDE No 338 dated 13.04.2024. As per kind order and direction of my superior officer myself along with ASI Kalachand Singha, C/1443 Rohit Horizon , C/244 Samim Ali , C/ 678 Dipak Mandal and C/706 Tapan Debnath all are of Khalpara TOP, Siliguri PS, Siliguri Police Commissionerate left for Mahananda River Bed near Jyotinagar W/No 04 under Khalpara TOP, Siliguri PS to work out the information in hand. This refers Khalpara TOP GDE No. 339 Dtd. 13.04.2024 . At about 00.55 hrs on 13.04.2024 we arrived at Mahananda River Bed near Jyotinagar W/No 04 under Khalpara TOP, Siliguri PS. At about 01.05 hrs we found that 09/10 persons assembled in a dark place at Mahananda River Bed near Jyotinagar W/No 04 under Khalpara TOP, Siliguri PS and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 05 (Five) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also disclosed that they assembled there to commit dacoity in a house at Jyotinagar . On search of the apprehended accused persons I found (i) One Iron made Hasua and one Iron made sabol from the possession of accused Anjay Sharma (22) S/O Suranjan Sharma of Cooliepara, Dharam Nagar, P.S- Pradhannagar, Dist.- Darjeeling (ii) One sharp cutting knife and one plastic made charger torch light from the possession of accused Sachin Routh (25) S/O Manoj Routh of Khudiram Colony, Bagrakote, PS- Siliguri, Dist.- Darjeeling (iii) One Iron made Hasua, Screw Driver & One Blunt Iron Rod from the possession of Md. Raj (26) S/O Md. Sabir of Koyla Depo , Vivekananda Road, Ward No.- 07, P.S- Siliguri, Dist.- Darjeeling (iv) One Iron made Bhojali and one sharp cutting knife from the possession of accused Ronak Singh (19) S/O Binod Singh of Rajib Nagar, P.S- Pradhan Nagar, Dist.- Darjeeling (v) One Torch Light and One Iron blunt Iron Rod from the possession of Raghbir Das (19) S/O Kedar Das of Thhakar More, South Ambedkar Colony, P.S- Matigara, Dist.- Darjeeling .

During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally they admitted their guilt and disclosed that they had assembled there and taking preparation for committing dacoity at Jyotnagar Colony. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted five accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to Khalpara TOP under Siliguri PS. The search and seizure made in between 01.35 hrs to 02.25 hrs.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Anjay Sharma (22) S/O Suranjan Sharma of Cooliepara, Dharam Nagar, P.S- Pradhannagar, Dist.- Darjeeling (ii) Sachin Routh (25) S/O Manoj Routh of Khudiram Colony, Bagrakote, PS- Siliguri, Dist.- Darjeeling (iii) Md. Raj (26) S/O Md. Sabir of Koyla Depo, Vivekananda Road, Ward No.- 07, P.S- Siliguri, Dist.- Darjeeling (iv) Ronak Singh (19) S/O Binod Singh of Rajib Nagar, P.S- Pradhan Nagar, Dist.- Darjeeling and (v) Raghbir Das (19) S/O Kedar Das of Thhakar More, South Ambedkar Colony, P.S- Matigara, Dist.-Darjeeling and others and arrange for its investigation.
