On request by the Manager @ Toton Barman, I rushed to the accused's lottery vending table with the manager at about 9 40 A.M yesterday to resolve a outstanding balance to the accused as usual of My family business. On Demand of Weekly Outstanding by the Manager @ Toton Barman Suddenly, said debtor started verbally abusing manager, then I compelled to object but I astonished to observed he physically attacked upon me and tried to damage my scooter's body also without any reason as consequence I succumbed injury in my Back, Keens, chest, Elbows and Neck for which I rushed to the Siliguri District Hospital for Checkup the copy the medical report and Prescription Enclosed Here with issued on yesterday i.e 12/04/2024

In view of above I request to you kindly take immediate action against Mr. Bablu Das as per the law and ensure the safety of people like me. I am willing to cooperate with the authorities and provide any further information or assistance required for the investigation, the delay in filling F.I.R. is due to advice of medical officer at least for 24 hours so the delayed F.I.R. may be condoned.
