In producing herewith the accused person namely Kalu Barman (50 yrs), s/o- Late Haladhar Barman, resident of Bhujipani, Biman Nagar, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles under proper seizure list:
1. Ten (10) bottles of Himalayan Gold 60° UP India Made Liquor, each contains 600 ml @ Rs. 155/-.
2. Six (06) bottles of COSMOS FIFTY 50° UP India Made Liquor, each contains 750 ml @ Rs. 240/-.
(Total 10.50 ltrs & total value Rs. 2990/-)

I, SI Debabrata Kundu of Bagdogra PS, SPC, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person namely Kalu Barman (50 yrs), s/o- Late Haladhar Barman and the absconding accused person namely Smt. Dipa Barman (38 yrs), w/o- Kalu Barman, both are resident of Bhujipani, Biman Nagar, PS- Bagdogra, Dist- Darjeeling to the effect that on 13.04.2024 at 18:25 hrs I received secret source information that a huge quantity of liquor is stored at the grocery shop of one Kalu Barman & Dipa Barman situated at Bhujipani, Biman Nagar under PS- Bagdogra and the same has been selling illegally. Accordingly, I informed the matter to O/C Bagdogra PS and diarized the matter in GD vide Bagdogra PS GDE No. 546 dated 13.04.24. Subsequently, as per direction of O/C Bagdogra PS, I along with ASI Amit Lama, VP/02 Prodip Roy & CV/389 Janak Singh left for Bhujipani, Biman Nagar to work out the secret source information. This refers to Bagdogra PS GDE No. 547 dated 13.04.24. At around 18:55 hrs we reached at Bhujipani, Biman Nagar. The source indicated the shop. We saw some customers in front of the shop. Then we proceeded to hold raid at the grocery shop of suspect Kalu Barman & Dipa Barman. Seeing the Police personnel, they fled away from the spot. But we managed to apprehend one person at the said grocery shop and interrogated him. On interrogation, he revealed their identity as Kalu Barman (50 yrs), s/o- Late Haladhar Barman, resident of Bhujipani, Biman Nagar, PS- Bagdogra, Dist- Darjeeling and introduced himself as the husband of Dipa Barman, owner of said shop. We disclosed our identity and the input we had to him. We contacted with the local people to be present as witness during the process of search, seizure, if any but none of the local people agreed to be present as witness. Then, we conducted search at the said shop in presence of Police witnesses. On search, the above noted liquor was recovered from the said shop. On demand, he failed to produce any valid document/license for stocking and selling that liquor. He further confessed that he along with his wife Dipa Barman have been stocking and selling liquor illegally from the said shop for a long time for their wrongful gain. His wife Dipa Barman managed to flee away from the shop. Accordingly, I seized that liquor under proper seizure list & label and at last, arrested the accused Kalu Barman (as noted above) after observing all legal formalities and telling him the ground of arrest and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 18:55 hrs and 20:20 hrs on 13.04.2024.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person namely Kalu Barman (50 yrs), s/o- Late Late Haladhar Barman and the absconding accused person namely Smt. Dipa Barman, w/o- Kalu Barman, both are resident of Bhujipani, Biman Nagar, PS- Bagdogra, Dist- Darjeeling and arrange for its investigation.
