I, Sri Bikash Kumar Singhal, Son of Sri Ratan Kumar Singhal, resident of K.C. Dey Road, Behind F.C.I. Garage, Ward No.10, Siliguri, District Darjeeling do hereby inform you as follows:

1. That I am the owner in possession of huge quantum of land measuring around 12 Acres appertaining to and forming part of L.R. Plot No. 1120, 1121, 1122, 1124, 1126, 1128, 1129 & 1139 of Sheet No.13, recorded in Khatian No.1378 & 1381 of Mouza Binnaguri in the District of Jalpaiguri.
2. That for the purpose of Industrial development, land development and construction is going on in the aforesaid plot of land but the miscreants namely Md. Sonallah, Son of Abul Husen, resident of Akari Gach, Binnaguri, District Jalpaiguri, along with some unknown land mafias came to the site and started demanding gunda tax of Rs.20,00,000/- before the development and on our denial to give any single penny to them they became furious and tried to manhandling with us. Not only that they started to use slang and offensive language. It is pertinent to mention here that they openly declare that, until and unless their illegal and ransom demand will not be fulfilled, they will continue their illegal and nuisance activities in our land and damage the boundary wall, if construction will be carried on.
