Dear Sir,

With due respect, I would like to lay following few lines for favour of your kind consideration and necessary action:

That I was married to Sri Sagar Sarkar on 8<sup>th</sup> February, 2013 according to Hindu Rites and Customs at Maa Kali temple, Netaji More, New Jalpaiguri. My parents gave gold and silver ornaments, cash, furniture, clothes, utensils, etc. as dowry to satisfy the demands of my husband and other In-laws. My relatives also gave many gifts to me at the time of my marriage with Sri Sagar Sarkar.

That though each and every thing as demanded were given as dowry during my marriage, my husband and other In-laws expressed their dis-satisfaction and my husband and other In-laws started to torture me both physically and mentally for bringing more articles from my parental house.

That my parents and brothers helped my husband financially in constructing his house and in buying one vehicle (Tio Toto) which was registered as WB-73F/2152 but inspite of all these my husband and his well wishers did not stop tortures upon me.

That out of the lawful wed-lock I gave birth to two children, namely Sakshi Sarkar (daughter) and Ansh Sarkar (son) but my husband is not taking care of me nor my children and he is even not paying their school fees.

That I along with my children kicked out of my matrimonial home on 15<sup>th</sup> March, 2024 in the clothes we were wearing and my husband did not allow us to take anything with us.

That my husband also assaulted me with physically on that day for which I was treated in North Bengal Medical College and Hospital but I could lodge any complaint with your esteemed Office to save my married life.

That my husband Sri Sagar Sarkar lodged a false complaint/missing diary with New Jalpaiguri Police Station for which one person who always helped me during my bad days namely Sri Bhola Chakraborty of Road No. 4, Saktigarh was arrested by the authorities of New Jalpaiguri Police Station and when I came to learn about this I went to Police Station with my daughter to know the story but I was also detained there till 9.30 p.m. and the said Sri Bhola Chakraborty was released at 8.00 p.m. after executing a bond.

That my husband Sri Sagar Sarkar, the neighbours of his house and some members of Mahila Samity of that area compelled me to write one letter stating that I left my matrimonial home at my own sweet will for using the said letter against me.

That my husband and his anti-social friends are spreading false and fabricated news in the locality for defaming me and Sri Bhola Chakraborty for illegal and wrongful gain. My husband is also threatening me with dire consequences if I lodge any complaint against him and his friends.

That I am now living at my above address on rental basis.

That I apprehend danger to my life and the lives of my children.

Therefore, I humbly request you to kindly accept this First Information Report and to take necessary legal actions against my husband Sri Sagar Sarkar and others at the earliest and oblige.
