was solemnized with Bikay Gupta s/o Mohitlal Prasad

Darjeeling, under Hindu rites & rituals, but since
after my marriage, my said husband started subjecting
me for physical & mental cruelty, and never maintained

and now I am pregnant for 05 (five) months but
even after that he did not stopped his atrocities
on me.

On dt. 13.04.2024 at about 09:30 pm, when
I was at my matrimonial house at Nehru Road,

when I denied to go to Pune (Maharashtra) with
my said husband & his parents & along with my daughter.

Sir, the above noted alleged persons are very
desperate & dangerous in nature and they have
threatened me for dire consequences, & Kill me.

So, please take necessary action against my said
husband & his sister noted above.
