Sir,

In producing herewith (02) two arrested accused persons namely (1) Md Alamgir @ Bulla-30yrs s/o Md Jafir of Koiladepo, Ward No-07, PS Siliguri Dist Darjeeling (2) Ajay Barman-20yrs s/o Lt Goutam Barman of Koiladepo, Ward No-07, PS Siliguri Dist Darjeeling arrested on 15.04.24 u/s- 41 Cr.P.C along with following seized articles viz: -

1. One iron rod measuring about 16 inch (approx) from the possession of accused Md Alamgir @ Bulla which was kept on his right hand.
2. One iron made Knife approx 8 inch from the possession of accused Ajay Barman which was kept on his right waist.

I, ASI Debasish Das of Siliguri Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 15.04.24 at 00.10 hrs received a sources information that 7/8 youths have assembled at Dangipara near Rail gate under Siliguri PS for making preparation to commit dacoity in a house at Siliguri PS area. The fact was diarized in G.D vide Siliguri PS GDE No. 792 dated 15.04.24. Subsequently after sharing the information with my superiors and as per their direction, at 00.15 hrs myself along with SI Srimanta Chatterjee, ASI Imjamul Haque, ASI Subir Sen, Const/160 Soumen Sarkar, CVF/622 Ramanath Barman & CVF/283 Prasenjit Dey along with kits left for the place to work out the information. This refers to Siliguri PS G.D.E No 793 dated 15.04.24. We reached at Dangipara near Rail gate under Siliguri PS hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 02 (two) accused persons along with seized articles as mentioned above. However, the other five persons managed to flee away from the spot taking the advantage of darkness.

On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Siliguri PS area. They also stated that another five others fled away from the spot.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made in between 01.10 hrs to 02.25 hrs) Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them.

I accordingly brought the arrested accused persons along with seized articles at Siliguri Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit Dacoity in a house at Siliguri PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Md Alamgir @ Bulla-30yrs s/o Md Jafir of Koiladepo, Ward No-07, PS Siliguri Dist Darjeeling (2) Ajay Barman-20yrs s/o Lt Goutam Barman of Koiladepo, Ward No-07, PS Siliguri Dist Darjeeling and five others and arrange for its investigation.
