I Smt Amropali Roy nee Basu, wife of Sri Avishek Basu of 2A Balaidas Chatterjee Road, Opp to "Matri Sangha", Ward No-16, Hakimpara, P.O & P.S-Siliguri like to inform you that I have filed a domestic violence case against my husband namely Avishek Basu, S/o Sri Asit Kumar Basu, father-in-law namely, Asit kumar Basu s/o Late Ashwini Basu and mother-in-law namely, Sima Basu w/o Asit kumar Basu which is pending before the court of the Ld Judicial Magistrate 2<sup>nd</sup>, court at Siliguri being Misc. Case No. 154 of 2021 and there is an interim protection order where the respondents (My husband and in-laws) are restrained from doing any kind of act (direct or indirect) which amounts to domestic violence, upon the petitioner till disposal of the case and the I/C Siliguri P.S. was directed to provide all necessary legal assistance to the petitioner i.e me.

That since the last week my husband, my mother-in-law and my father-in-law are harassing me by various methods. They are trying to evict me along with my daughter and son, they are continuously harassing me and threatening me with dire consequences. I am being deprived of basic food, my husband and my in-laws are misplacing my personal belongings and using vulgar languages in front of my children. Yesterday i.e on

My husband and my mother-in-law and father-in-law in connivance with each other are threatening me and have also tried raising hands on me and have stated that they will throw me out of their house and deprive me of my children.

Sir, despite the order of the court for my protection I am unsafe with my children as they are continuing to torture me mentally, physically and emotionally.
