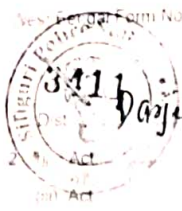

would like to inform you as follows: -

• That on 14/04/24 at around 7:30 pm when
my son was sitting at the river bank near
adarsanagar colony all of a sudden few
person namely ① Mahesh Sahani, S/o - N/K,
② Indu Sahani, w/o Mahesh Sahani ③ Keerjal
Sahani, D/o - Mahesh Sahani, ④ Neha Sahani,
D/o - Mahesh Sahani, ⑤ Nisan Sahani, S/o -
Mahesh Sahani started verbally abusing my
son namely Santosh Sahani, S/o - Rajendra Sahani.

• That while protesting against such antisocial
activities of the above noted accused persons all
of a sudden the accused no ⑤ with bad
intention touched my daughter namely Putal Sahani
and manhandled her. Upon such activity we
we restricted and protested them the accused
person namely ② Indu Sahani and accused ③ along
with ④ pushed my father against the wall namely
Bharat Sahani and he fell down on the ground.

• That later on the same transaction all the
