I, Bidyut Karmakar S/O Subodh Ranjan Karmakar of 87/20, Surjyasen Colony, Block - B, Ward No - 34 of SMC, P.S. New Jalpaiguri, District Jalpaiguri along with my partner, Arnab Dutta S/O Ajit Kumar Dutta resident of Rathkhola, P.O. Rabindra Sarani, P.S. Siliguri, District Darjeeling being an educated unemployed intended to start a business attracted with one SHRIBASH SARKAR (PAN DDGPS8657A) Aadhaar : 9101 8453 8380 S/O Anil Baran Sarkar of Desbandhupara, Near Gauriya Math, P.O. & P.S. Siliguri, District Darjeeling, who assured us to transer a F.L.& C.S. License from the existing owner to our name.

For such process me and my partner executed a MEMORANDUM OF UNDERSTANDING on 23/02/2024 between us for purchasing and selling the legally authorized wine initiating a company as "BSA PRIVATE LIMITED" pointing to a business place at Bidhan Road, Khadi building in rent under Sri Hriday Ranjan Dey.

Accordingly, the said SHRIBASH SARKAR confirmed us as F.L. License holder SHEO GULAM GUPTA of Lokhnathpur, P.O. Turturi, District Alipurduar, Pin - 736206 shall transfer his existing license to and favour of us with process of law and he has to receive Rs. 5,00,000/- as advance. For such an Agreement was executed on 27/02/24 for such payment and the payment was made on line to Shribash Sarkar in the Account of his wife SOMA SARKAR being SBI A/C No 41302405079, Pradhan Nagar Branch, IFSC: SBIN0006829.

Thereafter, the said Shribash Sarkar convinced us that he has got full set up with the said existing license holder – SHEO GULAM GUPTA (Phone No: 95939 42809/86702 41213) as the said existing license holder is ready to enter into written contract for such transfer of his license. Hence on 27/02/2024 agreement was executed with SHEO GULAM GUPTA (PAN JJHPS7473G) – being the License holder and with us including the said Shribash Sarkar.

I along with my partner sighed the said agreement agreeing to pay him Rs. 25 lacks for the said transfer of the **F.L. License of Sheo Gulam Gupta** and an advance of Rs. 15 lack to pay on sighing the said agreement. Since 27/02/24 to 12/04/24 we transferred **Rs.** 14,14,000/- on line to Shribash Sarkar, in the Account of his wife SOMA SARKAR being SBI A/C No 41302405079, Pradhan Nagar Branch, IFSC: SBIN0006829. We also handed as sum of amount **Rs.** 4,50,000/- in cash on miscellaneous purpose on various time which receipt shall be adjusted on the next payment as he convinced us.

On 06/04/2024 Shribash Sarkar handed us a License in the name of Milan Karmakar who is the wife of Bidyut Karmakar which was a copy of Finance Department, Govt. of West Bengal, for License for the retail Sale of Foreign Liquor for consumption and asked the final one shall handed over on the opening of our shop so as to withdraw the Liquor goods from the departmental go-down.

During these period he asked me to set up the premises where we have taken on rent for the purpose of the outlet, and also to set up racks and iron grills/ doors various steels racks with hording of name as prospective to open our said F.L. outlet on 14th April, 2024. We have collected the aforesaid amount on various process, as we two friends have some mutual savings month to month, doing some

project of business in future. The amount we have handed to him is our hard earned money in which we have full proof to that effect.

The day before opening as agreed, i.e on 13th April, 2024 the phone of Shribash Sarkar was switched off and as we rushed to his given address at Deshbandhu para, it was locked, none was available.

I rang to said - Sheo Gulam Gupta in this issue but he simply denies of such transfer of his F.L.License and he never had any contact with such **SHRIBASH SARKAR or SOMA SARKAR** or any other in such relation. We also rang once to Shribash Sarkar but he has sent a massage stating that for unknown reason he has been taken by police in front of Nabanno, Howrah and not to ring him further, as he shall make contact as soon as possible.

Sir, I and my partner, could make out that very cleverly he misleaded us to grab the money where there is much discrepancies in the documents he prepared, as the same photograph could be of a person in his Pan and Aadhaar which the Shribash Sarkar has. The Pan number verified towards SHEO GULAM GUPTA (PAN JJHPS7473G) – being the License holder is not correct, all such Govt. papers of License to Pan And Aadhaar has been purported and manufactured by him illegally to grab our money as we was blind to developing our future business.

Sir I pray to realize our money of Rs. 18,64,000/- and to take appropriate legal steps for the two - SHRIBASH SARKAR and SOMA SARKAR as we belief that they had other link of crimes with a chain of peoples as they with cool mind has pre-planned the entire process & procedure with a cool mind in which we not only believed to be true but did never had any view of entire process and procedure. During
