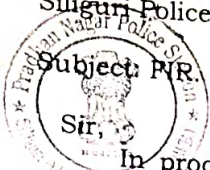

In producing herewith Five (05) accused persons namely (i) Arun Biswakarma (20) S/O Lt. Raju Biswakarma of Harin Budhrbiri, PS. Jhapa, Nepal, A/P Darjeeling More, PS. Matigara, Dist. Darjeeling, (ii) Chris Limbu (22), S/O Late Bipin Limbu of Samdur, PS. Ranipool, Dist. Gangtok, East Sikkim (iii) Suraj Chhetri (23), S/O Late Sastri Chhetri of Darjeeling More Gas Godawn, PS. Pradhan Nagar, Dist. Darjeeling, (iv) Mukesh Biswakarma (26) S/O Rajen Biswakarma of Nandok, PS. Ranipool, Dist. Gangtok, East Sikkim and (v) Rajesh Sah (35), S/O Rameswar Sah of Bara Mechia Busty, PS. Jaigaon, Dist. Alipurduar under arrest and the following articles under seizure :-

(i) One iron made sharp weapon locally called as "Bhojali" measuring 20 inch (approx) in length including its wooden butt recovered and seized from the possession of accused Arun Biswakarma, (ii) One iron made sharp cutting weapon locally called as "Bhojali" measuring approx 18 inch in length including wooden butt recovered and seized from the possession of accused Chris Limbu, (iii) One iron made sharp knife measuring approx 8 inches in length recovered and seized from the possession of accused Suraj Chhetri, (iv) One iron made breaking instrument locally called as "Sarashi" measuring 18 inches in length and one torch light recovered and seized from the possession of accused Mukesh Biswakarma and (v) One iron made breaking instrument locally called as "Sarashi" measuring 18 inches in length and one torch light recovered and seized from the possession of accused Rajesh Sah. I, ASI Manoj Kr Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted Five (05) arrested accused persons and their 05/06 unknown associates who involve in this crime to the effect that on 13.04.2024 night at 01.20 hrs received a specific source information that about 10/11 persons assembled at Shree Guru School Play ground, under PS- Pradhan Nagar, Dist.- Darjeeling equipped with deadly weapons and were taking preparation for committing dacoit at Champasari and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 711 dated 13.04.2024. As per your kind order and direction I accompany with ASI Biplab Kr. Das, ASI Jagannath Roy, C/1411 Ashok Roy, C/1415 Chandan Basak, C/1416 Dilip Barman and C/1413 Sujit Sarkar, all of Pradhan Nagar PS left for Shree Guru School Play ground under Pradhan Nagar PS to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No. 712 date 13.04.24. On the way, I informed the matter to RT van officer ASI Paresh Ch. Roy of Pradhan Nagar PS and directed him to come at Shree Guru School Play ground at Champasari Anchal to accompany with us for holding raid at Shree Guru School Play ground. At about 01.35 hrs we reached at Champasari Anchal, and at around 01.38 hrs night RT van officer ASI Paresh Ch. Roy along with his RT van force arrived at Champasari Anchal, and accompanied us. Then I shared the information to all the members of raiding team and briefed them accordingly. Thereafter, I contacted with my source and as pointed by the source we noticed that 10/11 persons assembled in a dark place at Shree Guru School Play ground and they were whispering in a very low voice. We cordoned the place with due care and caution. On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehend above noted Five (05) accused persons with deadly weapons in their possessions while 05/06 others managed to flee away from the spot taking the opportunity of darkness and open place. On interrogation, they disclosed their identities as noted above. On further interrogation they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with their associates assembled there and were making preparation for committing dacoity at Champasari and its surrounding areas.

Accordingly, I seized the above mentioned weapons of offence from their possessions under proper seizure list in between 02.05 hrs to 02.45 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. I accordingly brought all the five (05) arrested accused persons along with seized articles at Pradhan Nagar Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they along with their associates assembled there and making preparation for committing dacoity at Dagapur and its surrounding areas.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted five (05) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night for taking preparation to commit dacoity in a nearby affluent area at Champasari and its surrounding areas.

Under the above circumstances, I therefore pray before you that a specific case under proper section of Law against may kindly be started against the above noted five (05) arrested accused persons namely (i) Arun Biswakarma (20) S/O Lt. Raju Biswakarma of Harin Budhrbiri, PS. Jhapa, Nepal, A/P Darjeeling More, PS. Matigara, Dist. Darjeeling, (ii) Chris Limbu (22), S/O Late Bipin Limbu of Samdur, PS. Ranipool, Dist. Gangtok, East Sikkim (iii) Suraj Chhetri (23), S/O Late Sastri Chhetri of Darjeeling More Gas Godawn, PS. Pradhan Nagar, Dist. Darjeeling, (iv) Mukesh Biswakarma (26) S/O Rajen Biswakarma of Nandok, PS. Ranipool, Dist. Gangtok, East Sikkim, (v) Rajesh Sah (35), S/O Rameswar Sah of Bara Mechia Busty, PS. Jaigaon, Dist. Alipurduar and others 05/06 unknown miscreants and arrange for its investigation.
