[Sub: F.I.R against one Rohan Biswakarma (mob, 9635966123) and Smt. Santi Biswakarma (mob. 8918757548) for attempt to murder to me and forcefully kidnapping my minor son and keeping him away from me without my consent with the said unknown person Rohan Biswakarma.]

Sir,

I 'monoj Biswakarma, son of Money Biswakarma, resident of Dimbuline, Mohorgaon T.E. P.D. Gulma P.S. Pradhan Nagar, Dist- Darjeeling, pin-734009 would like to inform you that one Smt. Santi Biswakarma, daughter of Lt. Mohon Biswakarma is my wife and I have one male child who was born on 25-01-2019.

Sir, due to our differences in opinion, we are living separately since last two years and she used to stay in methibari along with our minor son. In the month of December, 2023, I came to know that my wife had left India along with her mother, leaving my minor son alone without proper care.

Sir, when I came to know about the condition of my minor son, I attempted several time to meet him but was always stopped by my said wife above named or her musclemen who threatened to kill me and my minor son.

Sir, recently I came to know that my ^{wife} is having illicit relationship with one Rohan Biswakarma, son of Not known, resident of Shivnagar, Darjeeling more, who is currently residing at my wife's house in methibari, Near SIT petrol pump, salbari, siliguri, Dist. Darjeeling by way of an illicit relationship with my wife.

Sir, today i.e. 14.04.2024 at around 11:30 Am, I contacted my wife above named, so give some new clothes to my minor child due to "Noboborsho" and my said wife instructed me to go to her house at methibari, Near SIT petrol Pump as she has kept my son at the same address.

Sir, to my utter surprise, upon my arrival I found the above named Rohan Biswakarma was staying at my wife's house as above mentioned and when I wanted to give my son the gifts, the said Rohan Biswakarma pushed me away and I fell down, then the said Rohan Biswakarma suddenly took out a sharp knife and cut my neck, arm in an attempt to murder me.

Sir, I anyhow managed to escape with the help of one local person, sir, thereafter, the said Rohan Biswakarma picked up my minor son and threw him inside the house and locked him inside. Thereafter, I was taken to the Hospital and there I contacted my family members.

Sir, I am living in constant fears of my life as today, attempt was made upon me to kill me by the said Rohan Biswakarma and with the conspiracy of my wife above named as they both are in an illicit relationship and therefore, wants to kill me, sir, also I fear that they torture or might cause harm to my minor child who has been forcefully kidnapped in my wife's house in methibari. In the above circumstances, I therefore, humbly pray before you to look into the matter immediately for the ends of justice and arrest the above persons so that my and my minor child's life be saved, as I fear that the above named persons might attack me and my minor son whom they have forcefully kept there, or my other family members and attempt to kill me or my son.

Hope your kind co-operation and need full legal action please in the interest of Justice.
