Respected Sir/Madam,

With due respect and humble submission that I Mr. Non Bahadur Sonar, Son of Bir Bahadur Sonar who is the resident of Matigara, Tumbajole, Rup Narayan Singh Nagar, Siliguri, West Bengal.

Sir, I would like to inform you that, Last Night 14th April, 2024. I went accompany with Mr. Nirmal Khati and Mr. Ashish Sunam, at Dhungana School Grounds at bhaghatin colony. Two days cultural program was organised by Brambhakta Saniti at Guring Basti, and we are invited there as a member to attend the cultural program. We all three as well as Mr. Nirmal Khati's wife Bandana Khati are the trustee of schedule caste pujaree foundation. So we all are always attend the such kind of cultural or religious program in this regards. So we reach there at 6:00 pm.

All are going. But after some time Mr. Nirmal Khati make a call to Krishna Upadhyay to come at bhaghatin colony, he came there but he was already drunked. It was raining, so we decided to drop him at his house at Nilan more, Kholabari, Champasari at 9:30 pm. Mr. Ashish Sunam started the car and we were heading towards the destination. On the way Krishna Upadhyay want to have more drinks and asked to buy some alcohol. They three consume alcohol then after again want some more so they enter doko restaurants, Nilan more. At that time Mr. Nirmal Khati singing at the Karaoke music. Nirmal

Nirmal Khatri told me for searching the Song on his mobile. At that time I was listening songs on my mobile earbud. I just told that please say him for searching. Suddenly Krishna Upadhyay started to use abuse word for me and my late mother. Mr Nirmal Khatri was also said abusing. At that time I just told them that why both of you used abusing word for my late mother, this is not good.

Krishna Upadhyay start to hitting me at my face, body and Nirmal Khatri came forward to joined him saying that we both are going to kill you and through you in the jungle. They were not stoped hitting me from both side in the car. Suddenly Ashish Sunam came there from doko restaurant. He saw that they were hitting me and about to killed me. So he rescue me from both of them. It was happened around 10:30 pm. I told Ashish Sunam to dropped me at my residence and I sat at the front side of the car. Ashish Sunam heading toward it to drop me at my house and the way again started Krishna Upadhyay started pulling my scarp behind the back sit of the car and Nirmal Khatri is also start to punching on my face. Krishna Upadhyay pulling and perching at my shoulder, Neck and face and I'm about to die if Ashish Sunam not rescued at that moment. All the way they (Nirmal Khatri & Krishna Upadhyay) rebok me that they will killed and threatening me whenever and wherever they meet me, and also they told me to that they ruined my family members.

So, Therefore I request you to take some action against these two people's named

- 1) Nirmal Khatri (President of Trustee)
- 2) Krishna Upadhyay (Friends of Nirmal Khatri)

If there will be happened such type of activities in  
future. They will be responsible for that Again. I
