I, Amit Adhikary, Inspector-In-Charge, Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint to the effect that today i.e on 19.04.2024 at about 18.25 hrs in course of Lok Sabha Election 2024 Mobile duty, I reached at polling station Ektiashal Tileswari High School at Ward No. 40 of SMC under Bhaktinagar PS jurisdiction. Honourable Police Observer Sri Dr. Chakkriala Sambasiva Rao, IPS of 03-Parliamentary Constituency who was also visiting the polling station premises at that time handed over to me one Subham Prasad S/o Munna Prasad of 2 No Jyoti Nagar Anchal Road, PS Bhaktingar, Dist. Jalpaiguri for being present inside the polling booth No 19/164 Ektiashal Tileswari High School. Honourable Police Observer also alleged that though the polling agent of TMC candidate Paresh Chandra Roy was already present inside the polling booth and the above noted Subham Prasad being reliever polling agent had no reason to be present inside the booth at the same time. On enquiry, it was learned from the Presiding Officer of 19/164 Ektiashal Tileswari High School namely Animesh Adhikary that he had issued a card to said Subham Prasad as reliever Polling Agent. Then after the completion of polling while he was busy in sealing of the EVMs and other materials said Subham Prasad entered inside the booth without his permission.

Hence, under the circumstances, I am lodging this complaint as FIR against Subham Prasad S/o Munna Prasad of 2 No Jyoti Nagar, Anchal Road, PS Bhaktinagar, Dist. Jalpaiguri for his misconduct in the polling station and disobedience of lawful direction of the presiding officer and registered a specific case vide Bhaktinagar PS Case No 335/24 Dtd. 19.04.2024 u/s 132 of the Representation of the People's Act, 1951.
