

FIR AGAINST Physical Assault by Shonai and S/o  
Bachu Dutta Mallaguri.

Respected Sir,

On 17<sup>th</sup> of April My father along with my  
two aunties, sister and uncle they were going to the  
sweet shop for ordering sweets, as the marriage ceremony  
is going on. But while being on the way, a girl and  
her uncle was holding a Pitbull dog, and the dog  
straight away came and torn away my sisters  
clothes, on such the girl i.e. my sister's father  
shouted and stated why they are keeping that dog,  
my father who is a victim had just mentioned to  
the culprit i.e. Shonai Dutta, have you ~~not~~ vaccinated  
your dog? just in that case my father was punched in, even  
otherose, was bleeding the teeth ~~fallen out~~ as he was wearing a ~~detach~~  
teeth, the left eye multiple times, and in the form of self  
defence my father slapped him too. The one of my  
aunt's in saving my dad and uncle even her  
clothes were all torn away in the back by that  
guy. My father came to the aunt's place and  
then after many hours police came and we  
all went to the culprit's place. But there his father

came and mentioned all the things in a different way to the Police. Even the Police didn't see who the culprit was. But they had promised to give away the treatment expenses to my father in everyone's presence. But my father claimed that his son has to say sorry, and they denied, even the Police mentioned it's okay if they are saying sorry, their son need not to say. He showed us so much power that he mentioned that every corner of West Bengal knows him, we can't do anything. And later that day we also came to mutual so that because they promised to bear the treatment expenses. They gave us a time at around 11 am i.e. on 18th April 2024 but we attended the meeting but they didn't come to the spot. There were many other brothers named Anthony who spoke to the culprit and the culprit mentioned he won't be taking any decision without his parents. They again gave us time at 6 pm, and we i.e. my mom, my grandmother from both side went to their place though they didn't receive our call. But Shonai's uncle disrespectfully told us to get out of their house and do anything we want. We didn't receive any kind of medical facility from them. Even Shonai's small, very younger brother disrespected us. The driver of the house gave us contact number 7477871760, and he promised to give medical expenses, and again we went home drowned eye's ~~home~~ and even made video of them mentioning us to fulfill medical assurance. But today at around 12 we went to Civil hospital and checked our papa, and the doctor prescribed many test and all. And also today we went to their home but no results were there. We are the victims so we need justice, we were ready to have mutual but they denied and disrespected us. Hope you will take the action immediately.
