I, Kalyan Pandey s/o Madhusudan Pandey,
a permanent resident of Chanchal Hospital Road,
P.O. & P.S. Chanchal, Dist. Malda-732123 like to
inform you that on 20.04.2024 at around 3.30 PM
my son Sabyasachi Pandey was going towards
Champasari from G.D. GORAKH School through NH-31
by riding his motorcycle bearing No. FN56L5344
was hit by one truck bearing No. ^{WB73}-FO961 which was
at a high speed and rash and negligently driven
when he ~~to~~ (my son) reached near Pradhan
Nagar Police Station. As a result of the direct
hit from the opposite direction by the truck
my son sustained injuries and was immediately
shifted to Siliguri City Hospital and admitted
there. The accident took place because of rash,
reckless and negligent driving of the truck bearing
No. WB73/FO961.

I, therefore, request you to kindly take
necessary steps against the driver of the
offending truck bearing No. WB73FO961 as per
law and do justice to my son undergoing
intensive treatment in Siliguri City Hospital.
