Sir,

In producing herewith following one (01) accused person namely Arjun Prasad (22 yrs) S/O Shib Kumar Prasad @ Bata of Surya Sen Colony, Mallaguri, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling under arrest and 01 improvised small fire arm measuring 30 cm in length with trigger, striking hammer, striking pin in working condition (Exhibit A") and three (03) rounds live .303 ammunitions (Exhibit B)", I, SI, Goutam Mallik of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the following arrested accused person namely Arjun Prasad (22 yrs) S/O Shib Kumar Prasad @ Bata of Surya Sen Colony, Mallaguri, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling. In this regard, I beg to report that today i.e. on 21.04.24 at 19.15 hrs, I received a specific secret information that one person namely Arjun Prasad of Mallaguri, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling is found moving suspiciously at Coolipara area under PS- Pradhan Nagar, Dist- Darjeeling with one 01 improvised small fire arm and live ammunition for committing heinous crime at the locality. Accordingly, I diarized the information in General diary vide Pradhan Nagar PS GDE No 1165 dated 21.04.24 and informed the fact to you. As per your kind order and direction myself along with SI Bandhan Roy, ASI Manoj Kr Roy, ASI Biplab Kr Das, C/1415 Chandan Basak, C/1416 Dilip Barman and C/1411 Ashok Roy all of Pradhan Nagar PS left for Coolipara under PS- Pradhan Nagar, Dist.- Darjeeling with investigation kit to work out the information by Govt. vehicle to verify the veracity of the information.

Under such urgent circumstances any search warrant or authorization for search could not be obtained for want of time. So we had to move fast without affording the miscreant the opportunity for the concealment of evidence or facility for his escape. At 19.35 hrs we arrived at Coolipara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling and as indicated by the source we noticed that one person was moving suspiciously below Mhananda river bridge, Coolipara. Then, we cordoned the place from every corner with due care and caution. On seeing police personnel approaching towards him, he tried to flee away from the spot but on hot chase we managed to apprehend him. On interrogation, he disclosed his identity as noted above. As per source information, that he possessed 01 improvised small Fire arm, hence, immediately I searched the said detained person and recovered 01 improvised small Fire arm which was kept concealed in his waist under his shirt and three (03) live ammunitions which were kept in right pocket of his half pant. He exclusively possessed one improvised Fire arm and three ammunitions illegally. On demand he failed to produce any document in support of the said improvised Fire arm and three live ammunitions which was found in his possession. Thus, when his involvement in carrying and possessing illegal Fire arm and ammunition was established, I then seized the said improvised small Fire arm measuring 30 cm in length with trigger, striking hammer, striking pin in working condition and marked as "Exhibit A" and thrtree rounds live .303 ammunitions and marked as "Exhibit-B" under proper seizure list duly signed by the witness and acknowledge by the accused person. The search, seizure and label were made in between 20.20 hrs to 21.30 hrs and subsequently I arrested him by preparing memo of arrest and informing him about the ground of his arrest.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused person namely Arjun Prasad (22 yrs) S/O Shib Kumar Prasad @ Bata of Surya Sen Colony, Mallaguri, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling is desperate and dangerous in nature, and he was carrying the said Fire arm ammunitions with an ill motive to commit heinous crime in the locality.

As he wilfully violated the regulation of Arms Act, I, therefore, pray before your good self that a specific case may kindly be initiated against the accused person namely Arjun Prasad (22 yrs) S/O Shib Kumar Prasad @ Bata of Surya Sen Colony, Mallaguri, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and its investigation may kindly be arranged.
