Sir,

I, Shyamal Sarkar, Son of Niranjan Sarkar, resident of Madhya Shantinagar, Bow Bazar, P.O. 2 No. Dabgram, P.S. Bhaktinagar, District Jalpaiguri beg to state that on 19.04.2024 I was the Polling agent of Bharatiya Janata Party of Booth No. 19/222 (South Santi Nagar Polling Station), Ward No. 36 of Siliguri Municipal Corporation within Dabgram-Fulbari Assembly Constituency under Jalpaiguri Lok Sabha Constituency for B.J.P. Candidate Sri Jayanta Roy. After completion of pooling I was coming back to my home at about 8 P.M. when I reached at Pipe Line, Fish Market, Madhya Shahtinagar, Near Bow Bazar, P.S. Bhaktinagar, District Jalpaiguri (1) Arjun Sarkar, Son of Madhab Sarkar, resident of Niranjan Nagar, Mother Teresa Road, Near Nepali Bari, P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri (2) Sadhan Basak, Son of Sachindra Basak, resident of Badur Bagan, Near Petrol Pump, Dina Busty, P.O. Ghogomali, P.S. Bhaktinagar, District Jalpaiguri, (3) Sudeb Das, Son of Late Nagar Bashi Das, resident of Dina Busty, Kalibari, P.O. Ghogomali, P.S. Bhaktinagar, District Jalpaiguri (4) Bappa Pandit, Son of Krishna Pandit, resident of Eastern Bypass, Ward No. 36 of S.M.C., P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri (5) Argha Chakraborty, Son of Late Apurba Chakraborty, resident of Niranjan Nagar, Chandal More, Ward No. 36 of S.M.C., P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri suddenly attacked me and started mercilessly beating me with wooden sticks, iron rods and by pelting stone stating that "শালা শুয়োরের বাচ্চা বিজে.পির পোলিং এজেন্ট হয়েছিলি তোকে আজকে পানে মেরে ফেলবো". Somehow, I save my life taking shelter in the house of one Ganesh Sarkar, near the spot. They also forcibly entered into the house of said Ganesh Sarkar and beaten me in presence of Ganesh Sarkar and his family members. On my shouting the local public came to the spot then the aforesaid antisocial left the place threatening that they will kill me at any opportunate moment. Due to the said brutal attack, I sustained several serious bodily injuries at my head, neck and all over body and immediately with the help of local people I was admitted at Siliguri District Hospital on 19.04.2024 and after treatment I was released/discharged on 21.04.2024. After discharge from Hospital I am lodging this complaint.


