In producing herewith one arrested accused person namely Bhola Routh (50 years) S/O-Lt. Suresh Routh of Natun Para, Ramghat, ward no 05 of SMC, P.O.-Siliguri bazar, P.S.-Siliguri, Dist-Darjeeling along with following articles under proper seizure list-

1] 11(Eleven) bottles of HIMALAYAN TUK TUK 80 UP country spirit (each bottle containing 600 ml) [Total 6600 ML/ 6.6 L] [Total value Rs-605/]

I, PSI Chiranjit Saha s/o-Madhab Saha of Khalpara TOP-II under Siliguri Police Station would like to lodge this written complaint against one namely Bhola Routh (50 years) S/O-Lt. Suresh Routh to the effect that today on 22/04/2024 at about 19.45 hrs while performing my evening mobile van duty, received a source information that one person is selling liquor in his house situated at Natun Para, Ramghat, ward no-05 of SMC under Khalpara TOP-II, Siliguri PS, without any valid license. Accordingly I informed the matter to the O/C of Khalpara TOP-II and as per his kind direction myself along with C/1486 Pradip Ghosh, C/1634 Yogesh Kumar Pandey had been to Natun Para, Ramghat, ward no-05 of SMC under Khalpara TOP-II, Siliguri PS to verify the veracity of the information. This refers to Khalpara TOP-II GDE entry no.588, dated-22/04/2024. On reaching there and as identified by the source it found that one person was selling and storing liquor in his house situated at Natun Para, Ramghat, ward no-05 of SMC under Khalpara TOP-II, Siliguri PS. Subsequently, I along with force cordoned the house and was able to detain the above noted person. On being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted bottles of liquor were found in his house. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 03 (Three) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of available witnesses. The whole process of seizure has been made in between 20.35 hrs to 21.05 hrs at the spot. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person namely Bhola Routh (50 years) S/O-Lt. Suresh Routh of Natun Para, Ramghat, ward no-05 of SMC, P.O.-Siliguri bazar, P.S.-Siliguri, Dist-Darjeeling after observing all sorts of formalities u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Bhola Routh (50 years) S/O-Lt. Suresh Routh of Natun Para, Ramghat, ward no-05 of SMC, P.O.-Siliguri bazar, P.S.-Siliguri, Dist-Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
