Respected Sir,

I am Prosenjit Chowdhury I would like to present my statement regarding Case no. -93/24 Dated 03/02/2024. To begin with, In the year 2010 I met a woman named – Dipali Saha (Now Deceased) and got engaged in a relationship, later I legally married her on 8/10/2010. Though we were legally married, we were residing separately. She told she was staying with her parents. After a few months of marriage she informed me that she was pregnant with my child and I decided to keep our child and asked her to move with me in a rented place. To my surprise she introduced me to a girl child named – Riya Chettri (6-7 Years) and told it is her child from her previous husband who had abandoned them. On human grounds I decided to shelter them in a rented place in Siliguri. Just after 2 days of moving in with me she went back to her house and came back with 2 more children named – Rakesh Chettri (10-11 Years) and Alisha Chettri (11-12 Years). She confessed that she had no relation with her ex-husband. As she was carrying my child I did not have the situation to leave her. After a few days Dipali's sister named – Soma Saha came with Dipali's ex-husband named - Keshab Chettri in my rented house and there was a verbal argument to take back Dipali and their children. On that day I came to know she was not legally separated from her ex-husband Keshab Chettri and also was informed by Keshab Chettri that Dipali and his biological child is Rakesh Chettri. Her 2 other daughters Alisha and Riya were not children of Keshab but of a third person Ranjit Sharma. During this argument Dipali did not move out with her ex husband instead preferred staying in the rented house. At this moment Dipali was 8 months pregnant and I could not understand what I should do. On 20-09-2011 Dipali gave birth to my only biological son from her named – Jeet Chowdhury. For the sake of my son Jeet I kept relation with her at that moment. But as days past I understood that she still kept relationship with her previous husband, instead she used to send money to Keshab Chettri from the household expenses I used to give her. She even used to send lunch and dinner to Keshab. I told her either give me divorce or divorce her previous husband. However she denied to legally divorce either of us. Out of disappointment I started detaching myself from Dipali and her other children. Out of humanity I just gave the educational, livelihood expense of her and her children. I moved out and for business purpose I started travelling to different places of West Bengal. I occasionally visited Siliguri for business purpose and to meet my son Jeet. I started getting information from the locals that she is in touch with her ex-husband Keshab along with multiple other men too, so I decided to mutually get separated from her on 2012. She agreed to mutually stay separated on the grounds that for the sake of our biological child Jeet's future I should buy/ make a permanent shelter (House) for Jeet. I started accumulating money and build a house at Amtala Chayan Para ward no. 37 Siliguri , P.S – Bhakti Nagar, PIN - 734004 on 2019. I allowed her to stay with my son Jeet in a 2 BHK flat of the house though registered the house in my name. There are few more flats in the house which I gave on rent. In between 2012 to 2019 I just kept relationship with my son Jeet and sent their daily and educational expenses. I allowed her to stay in my flat with my son Jeet but she brought in her other 2 Children Rakesh and Riya, Alisha by then was already

married to her husband Vicky Singh Rajput. I did not want to go into further arguments, so I allowed them to stay.

Since 2019 I just go to Siliguri for business purpose and stay in a different room of that house during my stay, another reason I get to meet my biological son Jeet. As Jeet is only 12 years and for the sake of mental health of a child I never brought our past relationship details to him and continued coparenting of him. However since last year Dipali's first son Rakesh Chhetri had started pressurizing his mother to register a flat in that house in his name as he wishes to get married soon. He frequently got into arguments with his mother to speak with me to register a flat and blackmailed his mother for cash and jewelry. Dipali out of pressure from Rakesh started requesting me to give more expense in cash, gold and started pressurizing me to transfer the property in her other children's name. Even Alisha Chhetri also started asking for money from her mother even after being married to Vicky and such argument between her children Riya, Alisha, Rakesh and their mother Dipali for property, money and jewelry became frequent. As Alisha pressurized and accused her mother Dipali for cash in need to start Vicky's (Alisha's Husband) business Dipali begged me to send Rs. 100000 (One lakh only) Vicky's account dated - 19/05/2023 and 20/05/2023. They did not stop to this whenever I used to visit Siliguri for business purpose all 3 of the children pressurized me to transfer property and demanded huge cash and gold. Out of pressure at times I even transferred money to their accounts like on 11/12/2023 Rakesh pressurized me to give money in his account so I had to send Rs 50000 (Fifty thousand only) and Rs 20000 (twenty thousand) on 23/12/2023 in his account.

Coming to the incident that happened recently, I visited Siliguri on business purpose on 26th January 2024. This time the argument and quarrel amplified and there was huge pressurization on me to transfer the property Riya, Rakesh and Alisha. Rakesh at times started attacking me by grabbing my collar and asking me for quick action. On seeing these things my own biological child Jeet on 27th January 2024 started questioning me - "Father, all these property belongs to us siblings then why is Rakesh dada fighting with you for property (Baba, ei sob property to sob amader bhai boner e. tahole Rakesh dada keno eto jhamela korche?)". Now after realizing that my life was on threat and even Jeet's future is also on threat. I decided to inform Jeet about the past of his mother's life, (about Keshab Chhetri), I informed Jeet that Rakesh, Riya and Alisha are his step brother and sisters and all these property does not belong to them. Jeet was surprised to know the truth and started asking his mother for more details. Post this arguments heated up Dipali started abusing me for telling the truth to Jeet. On 28th January 2024 evening upon my return from work when I asked for water Riya gave me cold drinks in a glass, around 10 minutes later I started feeling dizziness, I slept. On 29th January 2024 night I came back home around 8 PM and I was not feeling well. Rakesh served me dinner and after having that I felt dizziness again I don't remember anything. I woke up next day morning around 05:30 AM - 06:00 AM I started feeling very weak and I felt like someone has beaten me when I was unconscious, my back side of the head was paining. On my consciousness I found me lying down in a room alone. I started searching for my daily medicines and I could not find it. I started calling for everyone. I checked the other bed room was closed from inside. On my calling Riya and Rakesh came out. I asked where is your mother, they pointed to the closed bed room. We started calling Dipali, after several calling no one opened the door. Rakesh decided to break the door and found Dipali hanging on the ceiling fan. Rakesh immediately put her down there after as per suggestion of local people we took her to the Govt. hospital and she was declared dead. The body was taken for Post Mortem. I was too much puzzled at that time and could understand what my

returning from burning ghat I realized my gold chain (Around 17 Gram), and 2 finger rings (7 gram each) were missing from my neck and fingers respectively, this might have been snatched from me when I was unconscious. They did not have any regret for loosing their mother instead they were forcing me for property transfer. I understood even on 29th Night they tried to get me drugged and kill me and out of rage they have also beaten me on my head and whole body, to God's grace I was still alive so I decided to move out from that place feeling unsafe the very next day on 31st January 2024.

To conclude upon my understanding :-

1. Dipali has committed suicide because of the continuous pressure from her children for property and money. Also Dipali's past came in front of Jeet and this was shameful for her. This might have caused a mental depression for her.
2. Rakesh, Riya & Alisha claimed to be my children and are trying to use my surname. They even have made fake identity documents with my surname Chowdhury to proof themselves as my heir, so that they can they can claim my property. I declare they are not my biological children and all the documents are created by forgery. The birth certificate clearly states that the father name is different and I have never authorized them to take my surname;
3. I would like to state another fact that I was separated from Dipali mutually since 2012 and was not maintain a relationship of husband wife. Also as Dipali never got separated from her previous husband this marriage was null and void. After many years on 2020 I got into a relationship with Sampa Biswas which I informed Dipali back in 2020 but still Dipali refused to divorce me then. As a person I had to move on in life so I started a new life with Sampa Biswas.
