Late Ram Narayan Das, resident of Ward No. 4 SMC, Hemanta Basu Colony (Gwala Patti) PO: Siliguri Bazaar, PS: Khalpara TOP under Siliguri PS, Siliguri-734005, were going to our work as usual in our bicycles. When we reached near Margaret School at Pradhan Nagar at about 10 am today (22.04.2024) suddenly one scooty bearing no WB 74 BM 8775 came from behind in a very high speed and very forcefully hit my friend Pappu Das, who fell down and become unconscious and was grievously injured. After this I along with the rider of the scooty brought Pappu Das in North Bengal Neuro Research Centre, Pradhan Nagar, for treatment. While I was busy with attending to Pappu Das, the rider of the scooty fled from the spot with his scooty. (I am attaching the photo of the scooty for your reference.)
