Subject: - Complaint regarding obstruction of performance of election duty.

Sir,

With due respect We would like to bring to your notice that we have been assigned MCC Team duty vide order no 24/EL dated 15.03.2024 of Sub-Divisional Officer, Siliguri. On 23.04.2024 (Tuesday) We along with our team members were performing our duty of removing defacement on Hill Cart Road divider in front of SDO office.


While removing defacement of flags of BJP at about 2 PM, We and our team members namely Sri Subrata Chowdhury, UDC of team 1 and Sri Ram Krishna Sarkar, Instructor, Sri Juyel Sekh, LDC and Sri Rajendra Das, Khalashi of team 2 were surrounded by a group of party workers of BJP. The party workers raised voices on us and took photos and videos of all our team members and obstructed us from removal of flags from road divider in front of SDO Office. There were 4 police personals with us and they were mute spectators. The Party workers threatened us of dire consequences if we remove the flags before 9 PM on 23.04.2024. Because of the above disturbance we were unable to discharge our election duty at that time. The above incident was also brought to the notice of ARO-26 Slg and Sub-Divisional Officer, Siliguri and O.C MCC, Siliguri.
