I Sri Bhaskar Nay, Officer-in-charge of Siliguri Fire Station performing election related duties came to know about the happening and proceeded to Baghajatin Park but could not find the miscreant.

Later Medical Test was done of my son from Siliguri District Hospital and finally I am bound to place the matter under your guidance.

My earnest request to your honour to take the matter seriously so that this type of deeds may not happen again for the betterment of human life and society.
