Sub: Interference and tampering of LT O/H line & infrastructure at Samarnagar under Pradhannagar CCC

Sir,

During inspection of 28.04.2024, it came to the notice of the U/S that, plastic PVC pipes have been wrapped around the naked LT O/H ACSR conductors in front of the under construction building of Raj Kumar Gupta(mob No-9641081257) at Samarnagar Bottala. On inquiry, it has been learnt from Raj Kumar Gupta, that one person named Pradip Roy(Mob No-9749769282), Address-Samarnagar ; has done the work of wrapping the plastic PVC pipes on 25.04.2024. A written statement in this regard has been received from Raj Kumar Gupta vide Memo No-3361 Dt-29.04.2024 at Pradhannagar CCC, WBSEDCL.

The work of wrapping PVC pipes on LT O/H ACSR conductor is an illegal one and might cause any untoward incident which might lead to loss of life.

As such, Pradip Roy (Mob No-9749769282), S/O-(not known), Address-Samarnagar; has unauthorizedly and illegally tampered with the electrical infrastructure of WBSEDCL and is liable for prosecution U/S 138 of Electricity Act 2003.
