I, SI Binup Mahato of NJP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Bikram Roy (22) S/o Lt. Jotin Roy of South Colony Bazar PS NJP Dist. Jalpaiguri under arrest along with following selzed articles;

- 15 (Fifteen) Nos sealed Bottles of Himalayan gold country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.
- 2. 18 (eighteen) Nos sealed Bottles of Himalayan FATA FATI India made Liquor 70 up, each bottle 300 ml, Marked as Exhibit-B from which 01 bottles taken as sample for examination Marked as Exhibit-B1

I am submitting a written complaint against the above noted accused person to the effect that on 29-04-24 at 20-45 hrs received source information that one person was selling Liquor illegally from his house at South Colony Bazar under PS New Jalpaiguri Dist.- Jalpaiguri without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and O.C. NJP PS and as per his instruction myself alongwith ASI Dhrubo Mishra, CV-297 Putul Roy CV-824 Niru Kr Yadav all of NJP PS, SPC left for South Colony Bazar to verify the veracity of information vide NJP PS GDE No. 1498 Dated- 29.04.24. On arrival at the spot at 21-35 hrs it was found that one person mentioned above was selling liquor illegally from his house at South Colony Bazar to his designated customers to earn huge money for his livelihood. On seeing the police party some customers as well as the seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses namely (1) Kajal Das (55) S/o Lt. Basanta Das and (2) Paritosh Mandal (31) S/o Parimal Mandal both of Panchkelguri Baribhasa More PS NJP Dist. Jalpaiguri I recovered the above noted articles from his possession from his house and seized the same as per proper seizure List and lebelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 21-55 hrs to 22-45 hrs (seizure Total approx 14.4 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Bikram Roy (22) S/o Lt. Jotin Roy of South Colony Bazar PS NJP Dist. Jalpalguri and arrange for its investigation.
