I, SI Binup Mahato of NIP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Narayan Ghosh (54) S/o Lt. Sachin Ghosh of N.S. Road, Bhaktinagar Pipeline, W.No. 35 PS NIP Dist. Jalpaiguri under arrest along with following seized articles,

1. 18 (eighteen) Nos sealed Bottles of Himalayan gold country spirit 60 up, each bottle 500 ml, Marked as Exhibit A from which 01 bottles taken as sample for examination Marked as Exhibit A1.

I am submitting a written complaint against the above noted accused person to the effect that on 30-04-24 at 18-45 hrs received source information that one person was selling Liquor illegally from his Tea shop adjacent his house at N.S. Road, Bhaktinagar Pipeline, W.No. 35 under PS New Jalpaiguri Dist - Jalpaiguri without any valid license. Accordingly I informed the matter to the duty officer of NIP PS and O.C. NIP PS and as per his instruction myself alongwith ASI Dhrubo Mishra, C/1662 Sejan Tarmang VP-13 Jamindaramt of NIP PS, SPC left for South Colony Bazar to verify the veracity of information vide NIP PS GDI No. 1536 Dated: 30-04-24. On arrival at the spot at 20-20 hrs it was found that one person mentioned above was selling liquor illegally from his Tea shop adjacent his house at N.S. Road, Bhaktinagar Pipeline, W.No. 35 to his designated customers to earn huge money for his livelihood. On seeing the police party some customers as well as the seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in presence of witness I recovered the above noted articles from his possession from his shop and seized the same as per proper seizure list and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as it's a violation under Bengal Excise Act. The seizure & arrest was made in between 20-25 hrs to 21-10 hrs (seizure Total approx 10.8 ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Narayan Ghosh (54) S/o Lt. Sachin Ghosh of N.S. Road, Bhaktinagar Pipeline, W.No. 35 PS NIP Dist. Jalpaiguri and arrange for its investigation.
