Sir,

In producing herewith one arrested accused person namely Kalipada Barman (71yrs) S/o. Lt. Tarini Barman of Kamatpara, PO Sahudangi Hat, PS Bhorer Alo, Dist. Jalpaiguri along with the following seized articles as per proper seizure list:

1. Twelve (12) sealed Bottles of Himalayan Gold 60 up Country Spirit, Indian Made Liquor each bottle containing 600 ml when packed, and Price of each Bottle is RS. 155.00.
2. One Nylon Bag.

[Total Quantity – 7.2 litres and Total Price – Rs 1860/-]

I, ASI. Kajal Chakraborty of Ambari Falakata Out Post under Bhorer Alo PS/SPC lodged a written complainant against the above noted person to the effect that today on 02.05.2024 during my K-39 morning mobile van duty vide Ambari-Falakata OP GDE No. 38, Dated: 02.05.2024 at 12:55 hrs received a source information from Kamatpara More under Ambari Falakata OP that the above noted person has gathered huge amount of liquor illegally at Kamatpara More for selling the same to the customer for his wrongful gain. Accordingly, I informed to O/C Ambari Falakata Out Post about the information. As per his kind instruction I along with, (1) C/393 Shyamal Ch. Roy (2) NVF/131 Bidhan Roy all of Ambari-Falakata OP, Under Bhorer Alo PS/SPC proceeds to Kamatpara More under Ambari-Falakata OP to work out the information. At 13:05 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Kamatpara and detained above noted person who disclosed his identity as noted above and recovered the above noted articles from his possession. On demand, he could not produce any valid license/documents in support of said liquor. He became nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly, I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person in presence of witnesses. The seizure was made between 13:15 hrs to 13:25 hrs. Then I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Kalipada Barman (71yrs) S/o. Lt. Tarini Barman of Kamatpara, PO Sahudangi Hat, PS Bhorer Alo, Dist. Jalpaiguri under proper section of law.
