I, ASI. Biswajit Ghosh of Ambari Falakata Out Post under Bhorer Alo PS/SPC lodged a written complainant against the above noted person to the effect that today on 02.05.2024 special mobile van duty vide Ambari-Falakata OP GDE No.66, Dated: 02.05.2024 at 22:15 hrs received a source information from Farabari Velkipara under Ambari Falakata OP that the above noted person has gathered huge amount of liquor illegally at Farabari Velkipara for selling the same to the customer for his wrongful gain. Accordingly I informed to O/C Ambari Falakata Out Post about the information. As per his kind instruction I along with, (1) C/975 Swarup Basak (2) NVF/119 Krishna Baidya all of Ambari-Falakata OP, Under Bhorer Alo PS/SPC proceeds to Farabari Velkipara under Ambari-Falakata OP to work out the information.
