Respected Sir,

I, Ashim Barman Son of Late Anil Barman, resident of Bholanath Para, Siliguri-734006 would like to hereby report that on Thursday, May 2, 2024, at approximately 9:00 PM, My Varity Store was vandalized and I assaulted by Kalaburi Roy@Kala Roy Son of Shit Roy Residing at Naresh More, Teli para, Siliguri-734006

The incident occurred at My Varity Store located at Naresh More, Teli para, Siliguri-734006. The accused, Kalaburi Roy@Kala Roy, vandalized my Varity store over a small brawl on buying a pan and Cigarette which was instigated by the accused with filthy language not from my end. The Vandalism casued me a financial loss of Approx INR 15000.00 (fifteen thousand) which is a very crucial amount for a small shop keeper like me.

Following the vandalism, the accused then proceeded to physically assault me. Kalaburi Roy@Kala Roy beat me with his fists and blows and broom stick causing me injuries in back, abdominal region, chest etc. After the same Kalaburi Roy@Kala Roy not only dispassionate himself on that but also further proceeded and choked me with all his will and his physical power during the assault. But somehow freed myself and saved my self. He also threated and used filthy language on me that he have good local connections and not to lodge an FIR on the incident if I do that he will not only harm me but also harm my family without any mercy.

I request that the police investigate this matter thoroughly and take strict legal action against the accused, Kalaburi Roy@Kala Roy, for vandalism and assault and also lodge and FIR on the Incident. Also further request you that please ensure that I can do business in peace and my family remained unharmed.
