Accordingly, I informed the matter to you and as per your kind direction I along with CV/ 706 Tapan Debnath, C/717 Hirak Ray and LC/ 1216 Pushpanjali Yonzon of Khalpara TOP under Siliguri PS left for the spot to verify the veracity of information.
