Respected Sir,

I, **SMT BIMLA SHARMA**, W/o Sri Soni Kumar Sharma, resident of Ganga Nagar, Ward No. 5 of S.M.C, P.O & P.S - Siliguri, District- Darjeeling, do hereby submit a written complaint against one **Naresh Agarwal @ Miku Garg, S/o Sri Anand Kumar Agarwal, Resident of Naya Bazaar, Ward No.8 of S.M.C**, to the effect that today i.e. on **3<sup>rd</sup> of May, 2024** at about **1.20 PM** the aforesaid person came in front of my house and initially started calling my husband's by name with some objectional words. Hearing which my husband left the house and raised protest against it. Thereafter, a hot altercation took place there. Suddenly the said **Naresh Agarwal @ Miku Garg** became furious and attacked with a roadside stone on my husband's head resulting that he received deadly injuries and thereafter he is admitted to Room No.308, Arogya Niketan Hospital, Khalpara, Siliguri where he is on the verge of life and death. It is imperative to note that the culprit, Naresh fled the scene immediately following the attack.

That in the aforesaid circumstances I humbly request you to set the criminal laws into motion and book the above said culprit under appropriate provisions of criminal laws.
