DEBASHISH SAHA**, Son of Late Narayan Chandra Saha, Resident of Sukanta Nagar Auto Stand, Ward No. 38, Near Janakalyan Ashram, Siliguri, PIN- 734006 would like to inform you that is an employee at Chanda Matching Centre Situated at Mahabirstan, Siliguri. That today at about 7:00 P.M. when I was cleaning the front side of my said shop one lady without any reason whatsoever started quarrelling with me and also verbally abused me with dirty and derogatory language. That when I protested to such abusive behaviour of her, she immediately brought her husband and son in front of the said shop and started physically assaulting me with kicks, blows, slaps and also injured my head with sharp deadly weapon. That somehow with local interference I was rescued from the merciless physical assault and was taken to Siliguri District Hospital for treatment.

Hence I pray before your goodself to kindly look into the abovementioned matter and take necessary actions against the abovementioned accused persons as per the due course of Law for the administration of Justice.
