Respected Sir,

I, Bapi Mukherjee, son of Shekhar Mukherjee, residing at Satyajit Nagar, Pradhan Nagar, Dist: Darjeeling, Pin: 734003, am lodging this FIR to report a distressing incident that occurred on the evening of May 5, 2024.

At approximately 6:30 PM yesterday, while I was at my residence, my wife brought to my attention the disappearance of our minor daughter, Aparna Mukherjee, aged 15 years. Alarmed by her absence, we immediately commenced a search for her whereabouts.

Subsequently, at around 7:00 PM, I received a call from Babli Khatoon, who informed me that two individuals, identified as Om Sha, son of Ashok Sha residing in Pokaijote, Kathpool, and Bittu Sarkar, son of Bappi Sarkar residing in Green Park, Mallaguri, were witnessed kidnapping my daughter from Green Park, Mallaguri, and fleeing with her on a scooty.

Upon receiving this distressing information, I promptly departed from my residence to locate my daughter. However, en route to Green Park, I was relieved to encounter my cousin brother, Rudra Mukherjee, had managed to locate and bring back my daughter safely.

Upon inquiry with my daughter, I learned that Om Sha and Bittu Sarkar had indeed abducted her from Green Park. Fortunately, due to the intervention of

local residents who raised an alarm, the perpetrators abandoned my daughter in Pokaijote and fled the scene.

In light of these circumstances, I hereby request the prompt intervention of the authorities to apprehend the perpetrators and ensure the safety and wellbeing of my daughter, Aparna Mukherjee. Due to the traumatic nature of the incident, my daughter was unable to provide immediate assistance in filing this complaint yesterday

Thank you for your attention to this matter. I trust that the necessary actions will be taken promptly to address this grave situation.
