With due regards, I, SMT. BANANI MANDAL, Wife of Sri Chayan Kumar Mandal, Daughter of Sri Pintu Mandal, Presently residing at Sukanta Pally, Near Shib Shakti Kalibari Road, Ward No. 33 of S.M.C., Siliguri, P.O. Siliguri Bazar, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to lodge this written complaint before your good authority to the effect that SRI CHAYAN KUMAR MANDAL, Son of Late Boran Chandra Mandal, Resident of C/O – Nansy Apartment, Deshbandhu Para, Ward No. 27 of S.M.C., Siliguri, P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling, Pin: 734004, is my legally married husband and our marriage was solemnized on 02/05/2023, according to the Hindu Rites and Customs, after observing all formalities of a Hindu Marriage on and from my parental house situated at Sukanta Pally, Shib Shakti Kalibari Road, Bhaktinagar, Dist. Jalpaiguri and subsequently, our said marriage was registered on 15/07/2023, according to the provision of the Hindu Marriage Act, 1955, before the Hindu Marriage Registrar Sri Bijoy Kumar Ghosh, Siliguri, Dist. vide Certificate No. WB32700400010100002750-2023-103298.

Though, our marriage was an arranged marriage and both the families were got acquainted with each other through the daily newspaper advertisement but at the time of negotiation of our marriage, my in laws have placed certain demands as dowry before my parents and as both the families have agreed to negotiate the said marriage between us, my parents had given so many valuable articles like Golden Ornaments, Furniture & Fixtures, Washing Machine, Refrigerator, Utensils and other valuable household articles which are Stridhan and entrusted the same to my husband and in laws members as per their demand for the sake of my future conjugal life with my husband and still now, all those Stridhan Articles are lying under the custody of my in laws house.

After my marriage, my husband brought me at my matrimonial house situated at C/O – Nansy Apartment, Deshbandhu Para, Ward No. 27 of S.M.C., Siliguri, P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling, where we started to live and co-habited together as husband and wife and in my matrimonial house, besides me and my husband, my Mother-In-Law Smt. Kalpana Mandal also used to reside there. Sir, I being a newly married wife, have entered into my matrimonial house by holding the hands of my husband with a lot of hopes, wishes and emotions to share with each other and also to take the responsibilities of my matrimonial

house as a wife but it was very unfortunate and unexpected for me that immediately after our marriage, I was humiliated and tortured by my husband and mother-in-law for the reason that the articles which were given to them, are not matched according to their status which they have maintained and also for not bringing any monetary fund from my parents but it is very much within their knowledge that my parents have incurred a huge expenditure towards my marriage and also to meet up the each and every demands of my husband and in laws members.

Sir, from very inception of our marriage, I was continuously mocked by my husband and in laws members. They have created pressure upon me to bring money from my parental house and on being refused, they have started to picked up quarrel with me on any tripling issues and also restricted me to talk with anyone and had also shifted the entire burden of the household chores upon me and compelled me to do all the household chores in my matrimonial house and considering my future conjugal life, I have started to work as per their full satisfaction and they have also stopped to provide sufficient foods to me in order to create more pressure upon me and sometimes, I used to sleep at night in empty stomach but considering my future conjugal life, I used to bear such type of torture of my husband and in laws members with a hope that in near future, they will definitely realize their own mistake but all my hopes have gone in vain due to their continuous torture.

During my stay at my matrimonial house, I have also noticed that my mother-in-law is a patient of mental disorder and she has been suffering with such mental disease since long and used to take several medicines to cure her mental health but I was not aware about the said fact prior to my marriage and they have intentionally suppressed the said fact to us at the time of negotiation of our marriage and even after knowing about the said fact, I did not make any protest against them and instead I tried my level best to discharge my marital obligations towards my marital life considering my future conjugal life and also to maintain peace and harmony in my matrimonial house though, I never received any warm reception from the side of my husband and in laws members and in return, I was subjected to mental and physical torture by my husband and in laws members. Within the same month of our marriage, I also came to know that my husband had a love and affairs with a lady who was the co-gym-partner of my husband and knowing the said fact, when I asked my husband not to make any contact with the said lady, he became furious and started to assault me physically and also abused me with some abusive, offensive and derogatory words and when I made protest against his such type of behaviour, my husband in conspiracy with his mother threatened to oust me from my matrimonial house forcefully.

Within a very short span of time, I have noticed the drastic changes in the attitude and behaviour of my husband. He started to consume

alcohol on regular basis and used to come home at late night in fully drunken condition and increased the intensity of torture upon me both mental and physically and also assaulted me in presence of my mother-inlaw and my mother-in-law instead of rescuing me from his hand, provoked my husband to continue the mental and physical torture upon me and also threatened me by saying that if I will not bring a sum of Rs. 5,00,000/only from my parents, they will not hesitate to oust me from their house forcefully and due to the continuous mental and physical torture, on the day of Rakhi i.e. on 31/08/2023, I have compelled to left my matrimonial house and went to my parental house and on the very same day in the evening, my husband along with his brother came to my parental house and makes apology before my parents and also assured me and my parents that he will not commit any torture upon me in future and believing his said version to be true, I again went to my matrimonial house with my husband in order to lead a happy conjugal life with my husband but my said hope did not last for more than few days as within a very short span of time, my husband again started tremendous mental torture upon me to fulfill his demand of dowry and on being refused, he threatened me to ruin my life permanently and also ousted me from my matrimonial house forcefully for which, I again compelled to take shelter at my parental house and started to reside therein.

During my stay at my parental house, I have decided to apply for SSC Examination but as all my original identity documents were lying in the custody of my husband, I could not apply for the same and thereafter, I asked and requested my husband to handover my original documents including my identity proof and educational certificates, to me but my husband in connivance with his mother, have flatly refused to return those documents for their wrongful and illegal gain and thereafter, finding no other alternative, I went to New Jalpaiguri Police Station and lodged a complaint against them narrating the said fact and thereafter, with the intervention of the police officers, my husband handed over my documents to me and very surprisingly, after appearing before the Police Station, my husband again confessed his guilt and makes apology before me and again assured me that he will not cause any type of torture upon me and also requested me to go with him to my matrimonial house and considering my future conjugal life, I again return back to my matrimonial house with my husband and thereafter, on 13/11/2023, my husband took me to Maldah to celebrate the festive of Diwali but after reaching there, my husband consumed huge quantity of alcohol and under the influence of alcohol, he started to assault me physically and also threw most abusive and derogatory languages towards me in public place which tantamounts to the modesty of a woman and after staying few days at Maldah under the threat of my husband, we return back to Siliguri on 19/11/2023 but they did not stop to commit mental and physical torture upon me and at that time, I was unable to bear the torture of my husband and his mother further and informed the matter to my parents and thereafter, my parents

came to my matrimonial house to resolve the disputes amongst us but my husband and his mother did not bother to humiliate and insult them in my presence and also driven out me and my parents from my matrimonial house forcefully on 09/12/2023 and thereafter, finding no other alternative, I went to my parental house with my parents and started to reside therein and during my stay at my parental house, my husband continuously threatening me and my family members with dire consequences and also threatened that if I lodge complaint against them, they will not hesitate to ruin my life and property.

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my husband namely Chayan Kumar Mandal and mother-in-law namely Smt. Kalpana Mandal as per the provision of law and obliged thereby.
