Sir,

In producing herewith three (03) arrested accused persons namely (i) Raja Sharma (32) s/o Late Tulshi Sharma of Ratanlal Basti, Ward No. 01, PO+PS Pradhan Nagar, Dist. Darjeeling (not verified) (ii) Md. Chottu (30) s/o late Md. Anwar of Mallaguri, Ratanlal Basti, Ward No. 01, PO+PS Pradhan Nagar, Dist. Darjeeling (not verified) (iii) Mastan Mamun (27) s/o Masaraf Hossain of Samsia Telipar, PS Kushmandi, Dist. Dakshin Dinajpur, At present residing behind Durga mandir, Kadamtala, PS Matigara, Dist. Darjeeling (not verified) along with the following seized articles, as per seizure list viz:

1. One (01) white color plastic sack containing one brown color cartoon box which includes One Hundred and Sixty (160) Bottles of R- Kuff+ Chloropheniramine Melate & Codeine Phosphate Syrup (each bottle containing 100 ml having batch no. TBHW-0177, Mfg 02/23, Exp. 01/25, MRP Rs. 175/- only) recovered from the exclusive and conscious possession of Raja Sharma and marked as "Exhibit - A".
2. One (01) white color plastic sack containing brown color cartoon box which includes Ninety Seven (97) Bottles Triprolidine Hydrochloride & Codeine Phosphate Cough Syrup Phensedyl (each bottle containing 100 ml having batch no. PHID23143, Mfg Nov/23, Exp. Jan/25, MRP Rs. 205.48/- only) recovered from the exclusive and conscious possession of Md. Chottu and marked as "Exhibit-B".
3. One (01) white color plastic sack containing brown color cartoon box which includes One Hundred (100) Bottles Triprolidine Hydrochloride & Codeine Phosphate Cough Syrup Phensedyl (each bottle containing 100 ml having batch no. PHD24040, Mfg Jan/24, Exp. Mar/25, MRP Rs. 205.48/- only) recovered from the exclusive and conscious possession of Mastan Mamun and marked as "Exhibit-C".

I, SI Malay Kumar Roy s/o Karuna Kanta Roy of Ambari Out Post under Bhorer Alo Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint against the above noted accused persons to the effect that today on 08.05.2024 at 14.25 hours, I received a secret source information that three persons are standing at Canal Road near Flyover Bridge under Bhorer Alo PS, SPC who are possessing huge quantity of Contraband Cough Syrup to deliver the same to his designed customers of Ambari area.

The matter was diarized vide Matigara PS GDE No 245, dated 08.05.2024 and informed the matter to Officer-in-charge of Ambari OP under Bhorer Alo PS, SPC in writing. At around 14.45 hours as per instruction of Officer In-charge I, along with SI Chetan Dungal, ASI Biswajit Ghosh, ASI Mantu Barman, C/975 Swarup Basak, C/625 Bhaben Das all of Ambari OP under Bhorer Alo PS, Siliguri Police Commissionerate left to work out the source information towards Canal road by Government vehicle vide GDE NO 246, dated 08.05.2024 and MCC No 556, Dated 08.05.2024 to verify the veracity of the source information. I also requested Mobile Van Officer ASI Rabi Tamang to come at Canal road to accompany with me during raid.

During the time of departure from office, I took an envelope, white paper, sealing wax, gum, seal, digital weighing machine (Certified by the weight and Metallurgy department) and other investigation kits as it would be needed if any narcotic substances were found. I, also requested videographer namely Mobarak Hossain @ Mobarak Md. s/o Akrul Md of Sudamgach, PO Kamarvita, PS Bhorer ALo, Dist. Jalpaiguri over his mobile phone to come to Canal Road near Flyover Bridge with his video camera to record the entire process of search and seizure if required.
