

I Smt Supriya Sarkar, Wife of Sri Bablu Sarkar, presently residing at Shaktigarh, Road No.06, Ward No.31 of S.M.C Shibram Sarani, Laketown, P.S-New Jalpaiguri, District-Jalpaiguri, do hereby inform you that my daughter Smt Dola Sarkar got married to one Sri Shiben Das, Son of Sri Sukamal Das, resident of Sukantapally, Near Chayantika Kalibari, at Siddheshwari Kalibari, Jalpai More, P.S-Siliguri, District-Darjeeling as per Hindu rituals and customs on 16.04.2023.

Everything was perfect at the initial days of marriage, after elapse of few months my son in law along with her father Sri Sukamal Das and mother Smt Arati Das started pressurizing my daughter to bring a sum of Rs 5,00,000/- (Rupees Five Lakhs) only from my husband so that their dowry requirements are fulfilled. We also gave a box bed according to the demands of Shiben and his parents.

Thereafter we could only manage a sum of Rs 1,00,000/- (Rupees One Lakh) only and gave it in cash to Shiben and his parents as a result of which my daughter was tremendously beaten and could not get up from the bed, Shiben tried to strangulate my daughter with an, intention to kill her, Shiben is a habitual drunkard and always used to come home in an intoxicated condition under the influence of alcohol and is a womanizer.

In the month of August 2023 my daughter conceived and she was not given proper food as Shiben and his parents wanted my daughter to terminate her pregnancy and when she revolted she was ousted from her matrimonial house on 03.10.2023, since then she is residing at our house i.e. her parental house.

On 30.04.2024 my daughter gave birth to a female child at Chetana Nursing Home, Jalpaimore, P.S-Siliguri, District-Darjeeling, since then my son in law did not come to visit or look his daughter and was unhappy as my daughter has given birth to a female child. Today at about 05:00 P.M Shiben came to our house in an intoxicated condition, came into our house and kicked in my daughters lower abdomen so that she succumbs in pain due to tear in her stitches, my husband and I ran to rescue my daughter but my son in law started beating both of us, my husband was attacked by an iron rod in his waist and my husband fell into a drain thereby grievously hurting my husband, my husband is presently admitted at Siliguri District Hospital battling in pain.

I therefore request your good office to look into this matter and take necessary action against Shiben and his parents for torturing my daughter and also again Shiben who with an intention to kill my daughter strangulated her., against Shiben for grievously hurting my husband with iron rod in his waist.
